Tenders/ bids shall be accepted only through online mode on the website and no manual submission of the same shall be entertained. All documents shall

be submitted electronically by uploading before 2.00P.M.on05-10-2020. The original /attested copy of all the documents shall be produced within three days of opening of the tender.

contractors who are registered for e-tendering and have valid password can only view /

format provided in tender document. For uploading the tender documents, the tenderer has to

remit the amount towards tender fee as well as the prescribed EMD through online payment

mechanism for e-procurement system of Govt. of Kerala. Only those tender schedules which are
