The original / attested copy of the documents shall be produced within 3 days from the date of opening of the tender. The tenderers can view the tender notification and download the same free of cost in the website. On submission of tender, the tenderer will have to remit the tender fee and EMD EMD electronically by net banking facility of SBI or any of the enlisted banks through SBI MOPS. The tender fee once paid successfully and credited to Kerala Water Authority account will not be refunded even if the tender is cancelled at a later stage or the tenderer fails to upload his tender.

Preliminary agreement in the prescribed form in Rs. 200/- Kerala Stamp paper dully signed and sealed shall be up loaded without fail. The price bid shall be filled up with prescribed format provided in tender document. For uploading the tender documents, the tenderer has to remit the amount towards tender fee as well as the prescribed EMD EMD electronically by net banking facility of SBI or any of the enlisted banks through SBI MOPS. The tender will be opened by the Superintending Engineer, Trivandrum / Authority after giving due information about the time and date in advance and in the presence of the bidders present at the time of opening.
