The remittance of tender fee and bid security (EMD) shall have by online payment through credit card/net banking.

Once the payment transaction is successful, the bidder will get a transaction reference number which has to be retained by him. Unless the tender cost and bid payments are made successfully, the submission of tender will not be possible.

If any of the dates mentioned above happens to be a holiday, the actions will be conducted on the next working day. All other relevant rules followed by KWA shall be applicable.
