The required tender fee need be paid at the time of submission of bid only.

For uploading the tender documents, the tenderer has to remit the amount towards cost of tender documents as well as the prescribed EMD through online payment mechanism for e-procurement system of Govt. of Kerala (Online payment through SBI MOPS Only). Only those tender schedules which are downloaded from the website will be considered. They can also contact over phone or by mail to the regional offices of Kerala State IT Mission in the addresses available in the website for further assistance. All other relevant rules followed by the KWA shall be applicable to these tenders also.
