Tender fee and EMD mentioned above should be remitted through online payment mechanism for e-procurement system of Govt. of Kerala. Bidders are advised to visit the “Downloads” section of e-Procurement website (www.etenders.kerala.gov.in) for detailed instructions on making online payment using internet banking facility of SBT or by using NEFT/RTGS facility. The tenders shall be submitted electronically to the Superintending Engineer, PH Circle, Thiruvananthapuram in the method available at the web site www.etenders.kerala.gov.in. Tenders/ bids shall be accepted only through online mode on the website and no manual submission of the same shall be entertained. All documents shall be

submitted electronically by uploading before 3.00 PM on 04/09/2020 . The original /attested copy of all the documents shall be produced within three days of opening of the tender.

The tenderers can view / download the tender notice and other tender documents, free of cost from the website. Intending tenderers may enroll themselves for e-tendering in the website www.etenders.kerala.gov.in. One time registration is valid for all KWA tenders. The contractors who are registered for e-tendering and have valid password can view / download the Tender Documents. The Tender Schedule shall be filled up in the prescribed format provided in tender document. For uploading the tender documents, the tenderer has to remit the amount towards tender fee as well as the prescribed EMD through online payment mechanism for e-procurement system of Govt. of Kerala. Only those tender schedules which are downloaded from the website only will be considered.
