All documents/attested copy shall be submitted electronically by scanning and up loading before 2.00 PM on 04.09.2020. The original /self attested copy of the documents shall be submitted to Executive Engineer on or before 07.09.2020, 2.00 PM.

The tenderers can view/download the tender notice and other tender documents free of cost in the website. Intending tenderers may enroll for e-tendering from the website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). One time registration is valid for all KWA tenders. On enrolment, they will be allotted with a user id and password. The contractors who are registered for e-tendering and have valid password can only view / download the tender schedule. The Tender Schedule shall be filled up in the prescribed format provided in tender document. For up loading the tender documents, the tenderer has to remit the amount towards cost of tender documents as well as the prescribed EMD through online payment gateway. Only those tender schedules which are downloaded from the website will be considered and Photostat /copies will not be considered.

The tenders will be opened by the Executive Engineer, P H division, Pathanamthitta in the presence of the bidders present at the time of opening. The bidders are advised to be present for the opening of tender.

If any of the dates mentioned above happens to be a holiday, the action will be conducted on the next working day.
