Read:- Resolution No.11040 of the 414th meeting of the Authority held on 29/05/2020.

ORDER

The Centre for Water Education (CWEd), Kerala Water Authority provides training to Kerala Water Authority staff and also rents its facility to other departments and agencies for their training purposes. The rent for its various facilities was fixed 4 years back. The Training Advisory Committee which met on 08/07/2019 proposed revision of rent for the facilities at CWEd. The proposal was placed before the KWA Board.

The Authority, in its 414th meeting held on 29/05/2020, resolved to revise the rates for renting the facilities at CWEd as follows.

1.CWEd - Training Centre

a) Rent per day (10AM - 5 PM)

Facility	Rate for Govt/ Public Sector	Rate for others
1. Lecture Hall (A/C)	Rs.10,000/-	Rs.12,000/-
2.Computer Lab (A/C)	Rs.15,000/-	Rs.18,000/-

b) Rent for Additional usage of halls (Out of office hours)

1.Lecture Hall (A/C)	Rs.1,500/hr	Rs,1,700/hr
2. Computer Lab (A/C)	Rs.2,000/hr	Rs.2,500/hr



c) Rent for internet usage

1. Single access in class room	Rs.1,000/ day	Rs.1,000/day
2. Multiple access in Computer lab	Rs.1,500 / day	Rs.1,500/day

II. CWEd- Hostel Building

a) A/C Rooms (No. of Beds : 2)

1. Double Occupancy	Rs.2000/- (Rs.1,000/ Person)
2. Single Occupancy	Rs.1,500/-
3. Rent for KWA Board members for attending Board meeting.	NIL

b) Non-A/C rooms (No. of Beds : 2 or 3)

1. Rent/day/person for Non KWA Officer	Rs.500/-
2. Rent/day/person for KWA officer on training	Rs.150/-

c) Rent for Non- A/C rooms for CPHEEO Trainings - Rs.150/bed

- Single Occupancy - Rs.300/ for 2 bed room.
- Rs.450/- for 3 bed room

GST/Taxes are to be levied for the above charges as per the prevailing applicable rates.

In the above circumstances, order is hereby issued to revise the rates for renting the facilities of CWEd, as resolved by the Authority.
