The Executive Engineer, WSP Division, Kerala Water Authority, Palakkad invites competitive Electronic Tenders on behalf of Managing Director, Kerala Water Authority from experienced, Technically and Financially sound reputed bidders fulfilling eligibility criteria as described in the Bid documents for the following tenders. For viewing the detailed tender notice and tender documents the contractors has to enroll with KWA. Online enrolment form with instant activation for contractors and e-tender help desk manual are available in the home page of the website. One time registration is valid for all KWA tenders.

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on www.cca.gov.in. Once, the DSC is obtained, bidders have to register on www.etenders.kerala.gov.in website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

Bidders may contact e-Procurement support desk of Kerala State IT Mission functioning at Thiruvananthapuram, Ernakulam, Kannur and Malappuram over telephone or through email: etendershelp@kerala.gov.in for assistance in this regard. The contact details are available from the contact us link in the website.

Enrolled contractors can download the bid documents from the website free of cost. The tender fees need to be paid at the time of submission of the bid only.

The Bidder shall pay, a tender fee and Earnest Money Deposit (EMD) or Bid Security amount as per the tender documents through e-Payment facility provided by the e-Procurement system in the following manner:

State Bank of India (SBI) Internet Banking/ National Electronic Fund Transfer (NEFT)/ Real Time Gross Settlement (RTGS)

Single transaction for remitting Tender document fee and EMD: Bidder should ensure that tender fee and EMD are remitted as one single transaction.

Bidders should ensure that the remittance confirmation (UTR number) received after NEFT/RTGS transfer should be updated as it is, in the e-Procurement system for tracking the payment.

The tenderer shall produce before 02.11.2020 at 1.00 PM the original documents of the tenders scanned and uploaded including the preliminary agreement executed in the prescribed Kerala Stamp paper (Rs. 200/-).

In the event of discrepancy between the scanned copy and the original submitted or if the tenderer fails to submit the documents within the prescribed time, the tender submitted by the tenderer shall be summarily rejected and the EMD forfeited.

The tenderer has to remit the amount towards the cost of tender documents and EMD through online payment gateway in time. The bid submission is allowed upto the last date and time given in this tender notice. The bidder gets acknowledgement receipt as proof of online submission. The list of documents submitted by the bidder is available as proof in the receipt.

Tender shall be opened in the presence of the Bidder or their authorised Representative who chooses to attend the specified tender opening. The participating bidders can view the bid opening online and view the rates of competitors after tender opening. In the event of the specified date being declared a holiday, the event shall take place at the same time on the next working day.
