The tenderers can view the tender notification and download the same free of cost in the website. On submission of tender, the tenderer will have to remit the tender fee and EMD EMD electronically by net banking facility of SBI or any of the enlisted banks through SBI MOPS. The tender fee once paid successfully and credited to Kerala Water Authority account will not be refunded even if the tender is cancelled at a later stage or the tenderer fails to upload his tender.
