kerala.gov.in. All documents (attested copy) shall be submitted electronically by scanning and up loading. The original / attested copy of the documents shall be produced within 3 days from the date of opening of the tender. The tenderers can view the tender notification and download the same free of cost in the website. On submission of tender, the tenderer will have to remit the tender fee and EMD *electronically*.by SBI MOPS(internet banking) mode of payment. The tender fee once paid successfully and credited to Kerala Water Authority account will not be refunded even if the tender is cancelled at a later stage or the tenderer fails to upload his tender.

Preliminary agreement in the prescribed form in **Rs. 200/-** Kerala Stamp paper dully signed and sealed shall be up loaded without fail. The price bid shall be filled up with prescribed format provided in tender document. For uploading the tender documents, the tenderer has to remit the amount towards tender fee as well as the prescribed EMD through SBI internet banking. The bidders are advised to be present for the opening of tender. If the opening date mentioned above happens to be a holiday, the action will be conducted on the next working day. All other conditions of invitation of tenders will be as per prevalent rules in Kerala Water Authority.
