The tenderers can view the tender notification and download the same free of cost in the website. On submission of tender, the tenderer will have to remit the tender fee and EMD *electronically*.by SBI MOPS(internet banking) mode of payment. The tender fee once paid successfully and credited to Kerala Water Authority account will not be refunded even if the tender is cancelled at a later stage or the tenderer fails to upload his tender.

The price bid shall be filled up with prescribed format provided in tender document.
