Item No. I (1) Minutes of the 401<sup>st</sup> meeting held on 24/04/2018

The Authority reviewed the decision vide Resolution No.10667 and directed the Managing Director to submit the reasons for disqualifying the L1 bidder. The decision was to award the work to the L2 bidder at his quoted rate. It is also directed to ascertain this specifically with respect to the CVC guidelines.

The Authority confirmed the Minutes of the 401<sup>st</sup> meeting held on 24/04/2018 except Resolution No.10667.

The Authority discussed the agenda in detail and noted that the subject tender is the first tender for the deposit work of providing drinking WSS to Central University of Kerala at Periya in Kasaragod District. Two bidders have submitted their offers and both are prequalified. The lowest tenderer is Sri.K Kannan, Kannur with the quoted amount of Rs 8,94,00,000/-which is at 10.87% above tendered PAC of Rs. 8,06,37,519/- based on DSR 2014 and KWA SoR 2014 and 5.68% above estimate PAC of Rs. 8,45,89,010/- based on DSR 2016 (PRICE) and 1.33% below the TPAC based on the LMR estimate amount of Rs. 9,06,01,149/-. The Authority resolved to accord sanction to award the work of "Deposit Work-Drinking WSS to Central University of Kerala at Periya in Kasaragod District-Construction of Intake well cum Pumphouse and approach road. Supplying and laying RW Pumping Main. Construction of 4.00 MLD WTP and supply and erection of pump sets" to the lowest tenderer Sri.K Kannan, Kannur at the reduced amount of Rs. 8,87,01,271/- after limiting to 10% above tendered PAC of Rs. 8,06,37,519/- based on DSoR 2014 and KWA SoR 2014 with the directions that the electrical work should be executed through a licensed electrical contractor as per IE rules and to prepare the billing/payment schedule as per the prevailing order and also incorporating the item of supply & erection of 1 no 200mm flow meter. The CUK shall be informed regarding the additional amount incurred towards tender excess and centage charges @ 12.5% with direction to remit the same as per provision in the agreement.

The Authority discussed the agenda in detail and noted that this is the first tender wherein four bidders submitted their offers but only two were prequalified by the tendering authority. Out of the pre-qualified bidders. M/s Chicago Constructions International Pvt Ltd. JV with M/s Flowmore Ltd, Haryana, M/s Porel Dass Water and Effluent Control Pvt Ltd., Howrah and M/s Oriental Automation Systems Pvt Ltd., Bangalore, has quoted the lowest amount of Rs.56,29,00,000/- which is 10.50% below the TPAC based on DSR 2014. Regarding rejection of two of the bids, the tender committee noted that the cause of rejection was lack of technical qualification. The Authority noted the report that the prequalification criteria mentioned in the NIT for pump sets are short by 35HP. The qualification should have experience in erection of 410 HP instead of the criteria specified in the NIT as 375 HP. The request of the Superintending Engineer to accept the NIT criteria since the difference is small is agreed upon by the Board. After discussions, the Authority resolved to accord sanction to award the work to the lowest bidder M/s Chicago Constructions International Pvt Ltd. JV with M/s Flowmore Ltd, Haryana, M/s Porel Dass Water and Effluent Control Pvt Ltd., Howrah and M/s Oriental Automation Systems Pvt Ltd., Bangalore, at their quoted amount of Rs.56,29,00,000/- which is 10.50% below, the TPAC based on DSR 2014.

The Authority discussed the agenda in detail and noted that the present tender is the first tender wherein two bidders participated and both were pre-qualified. Among them, the lowest amount is quoted by Sri.S. Sivaprasad, Kollam for Rs. 8,42,00,000/- which is 9.16% below the tendered PAC of Rs. 9,26,94,000/- based on DSR 2014. The estimated amount based on LMR is Rs.10,46,27,645/- which is more than the lowest quoted amount. The Authority resolved to award the work "Implementation of Green Book-CWSS to Kalliyoor, Venganoor panchayath in Vizhinjam corporation area and Kovalam tourist area - Supplying, laying, jointing, testing, trial running and commissioning and maintaining distribution network in Venganoor Panchavath with 400mm DI K9 to 200mm DI K9 and 160mm to 90mm PVC pipe" to the lowest tenderer Sri. S. Sivaprasad, Kollam at the quoted amount of Rs. 8,42,00,000/- which is 9.16 % below the tendered PAC of Rs. 9,26,94,000/- based on DSR 2014 with direction to the tendering authority to prepare the billing/ payment schedule as per the NIT condition.

The Authority discussed the agenda in detail and noted that the subject tender is the first tender. Four bidders submitted their offers but only two bidders were prequalified by the tendering authority. Out of the two pre-qualified bidders, M/s.Suez India (P) Limited has quoted the lowest amount of Rs.10,62,23,281/which is 19.68% above tendered PAC based on DSR 2014. The Authority after discussions resolved to award the work "Operation and maintenance of raw water intake, Water

Treatment Plant, Pumping station etc at Aruvikkara, Tvpm constructed under JICA assisted Kerala Water Supply Project for three years" to the lowest tenderer M/s SUEZ India Private Limited at Rs. 7,94,27,717/- which is 10% above the Tendered PAC of Rs. 7,22,07,015/-(excluding provisional sum) based on DSR 2014. It is also resolved to limit the provisional sum to Rs 20,000,000/- per year. The tendering authority is directed to prepare billing/ payment schedule as per the revised PAC excluding provisional sum. The provisional sum shall be operated judiciously and shall be used only with the approval of the agreement authority. If the bidder is not willing to execute the work at the above rate, the work shall be retendered.

The Authority noted that there has been inordinate delay in the processing of the tender. The Authority directed the Managing Director to call for explanation from the officers who have processed the tender regarding the reasons for the delay and place before the next Board meeting.

in Agriculture department of Sr.P.T.Varghese for pension benefits. As per letter No.WS-C2/17/2017-WRD dated 02.08.2017, the Government have directed Kerala Water Authority that the Board of Kerala Water Authority can decide on the issue of counting prior service of an employee in lieu with the guidelines issued by the Finance Department vide Circular No.74/1999/Fin dated 04.12.1999 as well as GO(P).No.188/2010/Fin dated 25.04.2010. In the above circumstances the request of Sri.P.T.Varghese, Surveyor Gr.I (Rtd) to reckon the prior service rendered in Agriculture department as qualifying service for pensionary benefits in Kerala Water Authority is brought before the Authority for a decision. It is reported that there are no Rules and Government Orders for counting prior service rendered in Government Department as qualifying service for pension in Kerala Water Authority and vice-versa and 240 numbers of such requests are pending. Considering the above and in light of the present financial position, the Authority resolved to reject the representation of Sri.P.T.Varghese, Surveyor (Rtd) for counting his prior service rendered in Agriculture Department as qualifying service for pension in Kerala Water Authority.

The Authority discussed the agenda in detail and noted that this is the first re-tender with TPAC Rs. 699.55 Lakhs. The first tender was cancelled because only a single offer was received. It is also noted that no provision is given in the AS or estimate for remitting the road restoration charges. Superintending Engineer, PH Circle, Kollam further vide letter dated 04/05/2018 has reported that during Core committee meeting conducted by Kollam Corporation on 27/04/2018, Kollam Corporation agreed

to reimburse the road cutting charges and also submitted minutes of the meeting. The Authority noted the commitment of the Kollam Corporation to reimburse the road restoration charges and also the offer of the contractor to pay the road restoration charges in advance subject to the condition that the same shall be reimbursed along with running contract bills. However, ensuring the road restoration is the responsibility of the Authority. Hence the authority after detailed discussion resolved to accord sanction to award the work of "AMRUT 2016-17- Providing new water connection in Kollam Corporation" to Sri Sohail Shamsudheen at his quoted rate of 7,39,00,000/- which is 5.64 % above the tendered PAC only after receipt of the road restoration charges from the Kollam Corporation in advance.

- 1. The Kollam Corporation may be requested to remit the road restoration charges in advance. If the same is not received within a month the tender shall be cancelled.
- 2. While awarding the work, the supply and installation of meter box shall be included in the scope of work.

In the present tender, six bidders submitted their offers out of which five bidders were pre-qualified. Among the five qualified bidders, the lowest amount is quoted by Sri.Sali P.Mathai for an

amount of Rs.5,87,18,745/- which is 3.79% below the TPAC of Rs.6,10,30,792/- based on DSR 2014. Further, DSR 2016 and LMR (both under PRICE DEMO) estimate amount are sanctioned by Chief Engineer (CR) at Rs.6,75,29,003/- and Rs.7,00,01,511/- respectively. The quoted rate offered by the lowest tenderer is 16.12% below the LMR amount.
