Item No. III (3) KWA - RMC - Revision of water charges of water supply to Mahe Region from Kerala Water Authority - Waiving of water charge arrears

Res. No. 10706 The Authority discussed the agenda in detail. The 384th Board meeting of the Authority held on 22.01.2016 vide resolution No.10309 had decided to revise the water charges for the supply of water to Mahe @ Rs.28/KL with effect from 01.10.2014. Proceedings were issued on 24.02.2016 and the revised rate was made applicable from 01.10.2014

The Hon'ble Chief Minister of Pondicherry vide his letter dated 13.01.2017 requested to waive off the arrears since Pondicherry is a small Union Territory with limited resources while stating that they are charging Rs.3/KL only from their consumers. The following is also requested:

- 1. That they are ready to pay the water charges @Rs.21/KL instead of Rs.28/KL as revised rate
- 2. To allow 50% discount on water consumption arrear charges due to Kerala Water Authority for the period from 15.10.2014 to 29.03.2016.
- 3. To allow at least payment from prospective date only waiving off retrospective arrears.

The pre-revised rate is Rs.14/KL and the revised rate is Rs.28/KL. The Authority noted that the total water charges due for the period from 15.10.2014 to 29.03.2016 @ 28/KL amounts to Rs.405.82 lakhs. Fifty percentage of this has been remitted and the balance arrear amount to be remitted is Rs.202.91 lakhs. After discussions, the Authority resolved to waive the outstanding water charge arrear amount of Mahe region for the period from 15.10.2014 to 29.03.2016 amounting to Rs.202.91 lakh. In effect, the revised rate is applied only from April, 2016.

Item No.IV (2) AMRUT –2017-18- Water Supply projects Kannur Corporation-Rehabilitation of existing old distribution networks, valves, house service connections and interconnection with existing lines of Elayavoor Zone - Board Resolution-Submitting reasons for disqualification of L1 tender

Res. No. 10708 The Authority discussed the agenda in detail and noted the report that as per the CVC guidelines there is no clear direction on disqualification of a prequalified bidder after price bid opening. However in the case of L1 bidder backing out, the following guidelines are mentioned in CVC letter No.3(V) 99/9 dated 1.10.1999.

"Some of the organisations have sought clarification as to whether they can consider the L2 offer or negotiate with that firm, if L1 withdraws his offer before the work order is placed, or before the supply of execution of work order takes place. In this regard it is clarified that such a situation may be avoided if a two bid system is followed (techno-commercial) so that proper assessment of offers are made before the award of work order. Therefore if L1 party backs out, there should be retendering in a transparent and fair manner." Though L1 bidder has not backed out in the present case, as the bidder has failed to prequalify, guidance of the above CVC direction is adopted herein.

After discussions, the Authority resolved to cancel the subject tender and retender the work.

Out of the pre-qualified bidders, Sri. Joseph John, Monippillil House, Muvattupuzha, JV with M/s Anurag Engineers, has quoted the lowest amount of Rs.33,73,21,000/- which is at 3.245% above the TPAC of Rs.32,67,19,822/-. LMR amount is seen sanctioned by CE for Rs.34,36,33,165/- and the lowest quoted amount is 1.84% below the LMR amount. The Authority noted that the total AS amount for the project is Rs.56.87 Crores. The AS provision for this work is Rs.30,60,74,368/-. But the tendered PAC is Rs. 32,67,19,822/-which is in excess of the AS provision for this work. The tender excess for this work is 3.245%. The State High Power Committee for AMRUT has agreed to allocate additional funds for the tender

Overall, after analyzing the delays, the consultant M/s TECC has recommended attributing a net delay of 30 days on the part of the contractor for charging of Liquidated Damages purpose. It is also noted that certain civil works and installation works which could have been done before 30.06.2014 was delayed beyond the allowed period. The value of such delayed works (between 30.06.2014 and 14.11.2014) comes to approximately Rs.2 crores. But it is also noted that these works have not affected the commissioning of the project as power was available only by 14.11.2014. The contractor has completed the remaining works within a short period of 84 days on the availability of power recommended by the Engineer. Though KWA was utilizing the facility since February 2015, the partial taking over of the completed section was not done and the taking over of the whole package was extended for want of only commissioning activities, KWA was benefitted by utilizing the facility without taking over and declaring the DLP. For the pre DLP period of ten months, KWA was using the facility which was maintained by the contractor. Pre take over (DLP) O & M cost claimed by the contractor amounting to Rs.60.21 lakhs for each package was

works from 25% to 12.5%. Based on this, the Authority had resolved to levy 12.5% as centage charges for deposit works undertaken for State/ Central Government or Local Self Governments. But various LSGDs have reported audit objections on charging 12.5% centage charges citing para 1601.4 of PWD manual which restricts charging of 2.5% towards the cost of preparation of plan and estimates for the works undertaken for LSGDs. Now vide LSGD, Government Order dated 16.04.2018, it has been ordered not to charge 2.5% towards preparation of plan and estimate for LSGD deposit works as provisions of PWD manual is applicable to Kerala Water Authority also. The Authority discussed the matter in detail and resolved to charge centage charges @ 10% of the estimate amount only, as per the PWD manual for deposit works of LSGD with effect from 16.04.2018 (date of G.O).

Out of the 12.5% of the total centage charge for deposit works, the Board, in effect, resolved not to charge 2.5% (of the estimate amount) towards preparation of plan and estimate for LSGD deposit works w.e.f. 16.04.2018. It however noted that in case of deposit works of private parties, Quasi Government Organizations and Government of India works, 12.5% centage charges would continue to apply, unaffected, in tune with the provisions of the PWD manual.

The Authority discussed the agenda in detail. The NHAI had addressed to the Chief Secretary, GoK, to issue appropriate instructions to all utility owning agencies under Government of Kerala that supervision charges should be capped @ 2.5% of the approved estimate. It was also informed that as per 'Bhrathmala Pariyojana' scheme more than (40000 crores) will be spent by Central Government for the construction of 4/6 lanes National Highways in the State. The said infrastructure development will boost the overall development of Kerala State under Bhrathmala. Hence, as a mutual benefit, it was requested that supervision charges of utility shifting (KSEBL, KWA and Irrigation Department) agencies may be capped @ 2.5% of the estimated cost.

In the meeting convened by Chief Secretary on 25.06.2018 attended by the Secretaries of Power Department and WRD it was requested to cap the supervision charge at 2.5%. It was mentioned that in return the NHAI shall waive the license fee. Hence, the Authority resolved to reduce the Supervision charges of utility shifting to 2.5% for NHAI works. A proposal shall also be moved to NHAI to waive license fee in return for KWA having capped the supervision charges at 2.5%.

Item No. VIII (5) Restructuring of KWA

Res No.10740 The Authority discussed the agenda in detail. The finance Minister in his Budget speech 2019-19 has mentioned the following.

"173. Presently, Rs.300 crores is due to contractors, schemes

worth Rs.600 crores are in different stages of construction. Since the Central assistance ceased, many schemes are at a standstill. Water Authority itself should find a remedy for this revenue deficit. But Finance department will take initiatives to compensate the stagnation of the ongoing works. Letter of Credit system and bill discounting scheme with Government guarantee will be implemented in Water Authority as in the PWD. Water Authority should take initiative to implement schemes giving priority to KIIFB projects. A total revamping is essential in Water Authority as in the case of KSRTC".

The Authority discussed in detail about the speech and observed the following.

KWA already has a bill discounting system in which the entire interest burden is on the contractor. Adopting Governments LC and bill discounting system will adversely affect the finances of KWA. In the Government system 50% of interest burden is on the Government, which in turn will be charged on KWA, thereby affecting the plan allocation further. The Authority directed the HLC to further examine the pros and cons of adoption of Government BDS and place it before the Board for further consideration. The Authority also resolved to develop a ToR for appointment of consultants for a total revamping of the organization. The ToR adopted in the IIM-B study may be taken as a basis for the same.
