### ORDER

Kerala Water Authority is a unique state wide public sector establishment in drinking water sector with the aid of Government and with more than 25 lakh consumers at present. Jal Jeevan Mission (JJM) has been launched by Government of India which aims at providing Functional Household Tap Connection (FHTC) to every rural household by 2024, in collaboration with State Governments on a 50:50 cost sharing basis. It is the Central Government and State Government Policy to provide drinking water to all house holders in the state. This will increase the responsibility of KWA in drinking water sector of rural areas. Kerala Water Authority has only 346 regular Meter Reader posts to look after the water connections.

Kerala Water Authority have Revenue dues about Rs. 1200 crore to collect as water charges from its consumers. This amount cannot be recovered due to shortage of Meter Readers for proper issue of bills and taking reading in time. Hiring of people for meter reading makes large financial



commitment to Authority.

In Kerala Water Authority Disbursement of DCRG, Commutation and differential commutation to the pensioners are pending for last few years. The Hon'ble High Court of Kerala has issued a common Judgment to pay these pending pensionary benefits within 6 months. The Authority needs to increase its revenue to fully implement the court orders. It is necessary that, these financial obligations should overcome by efficient usage of existing staff for meter reading and revenue related duties to ensure financial security of the Kerala Water Authority.

Also Government of Kerala has ordered stringent financial control measures owing to the outbreak of Covid-19 pandemic and consequent lockdown. Hence it is required to strengthen revenue collection and to reduce the operational costs. For the effective strengthening of revenue collection, it is necessary to rearrange existing staff for meter reading.

Further more for effective customer service, staff have to be present at the field level for addressing their issues at the earliest. this will improve the customer confidence also.

In the above circumstances rearrangements and deployment of following employees, and ordered herewith for ensuring sufficient staffs for meter reading at the cutting edge level to increase revenue collection and also to deliver better service to the consumers.
