Once the payment transaction is successful, the bidder will get a transaction reference number which has to be retained by him. Unless the tender cost and EMD payments are made successfully, the submission of the tender will not be possible.

The bidder shall fill up technical bid sheet and price bids in prefixed formats and upload in the website along with NIT. Additional documents are to be scanned and uploaded in the website along with the cover documents. The tenderer shall produce before 5.00 PM on 06.01.2021 the original documents of the documents scanned and uploaded including the preliminary agreement executed in the prescribed Kerala Stamp paper (Rs.200/-)

In the event of discrepancy between the scanned copy and the original submitted or the tenderer fails to submit the documents within the prescribed time, the tender submitted by the tenderer will be summarily rejected and the EMD forfeited.
