ORDER

Sri. K.S. Surag Son of Late K.V. Suresh, U D Clerk, P.H. Division, Thrissur had submitted an application for Employment assistance appointment under Compassionate Employment Scheme. While such applications were placed before the 404th Kerala Water Authority Board Meeting and the Authority vide Resolution No.10732 resolved to direct the Managing Director to send applications to Government following the necessary formalities as per rules in force. The application of Sri.K.S. Surag Son of Late K.V. Suresh, U D Clerk, P.H.Division, Thrissur under Compassionate Employment Scheme was submitted to the Government along with the verification report from the District Collector concerned. Now the Government of Kerala vide order 3rd above, have accorded sanction for appointing him as Office Attendant based on the qualification possessed by the applicant.

In these circumstances Sri.K.S. Surag Son of Late K.V. Suresh, U D Clerk, P.H.Division, Thrissur is provisionally appointed as Office attendant in the Scale of Pay of Rs.17000-37800/- under Compassionate Employment Scheme and posted to P H Section, Oollur under W S P Sub Division, Chalakudy (the service of the incumbent shall be utilised for revenue related activities) in the existing vacancy.

The appointee shall join duty within 15 days on receipt of this order failing which the appointment will be liable to be cancelled without further notice. The date of joining/non joining duty shall be reported to this office along with the filled up proforma.

The appointee shall be on probation for a period of 1 year on duty within a continuous period of 2 years. The appointee shall produce the following original documents as the time of



joining duty.

- 1.Certificate to prove the age and qualifications.
- 2.The Medical Fitness obtained from Medical Officer not below the rank of a Civil Surgeon with finger impression and photo attested as prescribed in G.O(P) No.20/2011/P & ARD dated 30.06.2011(published in KWA Website)
- 3.Duly filled Annexure 1 Form for Police Verification as per G.O.(P)No.79/2009/Home dated 05.06.2009.
- 4.Form for details of the movable & immovable property to be filled at the time of joining service" as per G.O(P) NO.171/2016 dated 15.11.2016
- 5.Recent Passport size photograph (4 Nos.)
- 6.Identification Proof (Voters Identity Card/Aadhar Card)
- 7.Fresh Service Book
- 8.Declaration as per G.O(Rt) No.5/2018/P&ARD dated 21.02.2018

As per G.O (Rt) No.5/2018/P & ARD dated 21.02.2018 the candidate should submit a declaration to Managing Director, Kerala Water Authority at the time of joining that he shall must give lifelong protection to mother or father/widow / widower of the deceased employee. Moreover he shall protect minor sisters / brothers of the deceased employee, if any , till they attain majority. (This shall be recorded in the Service Book of the incumbent without fail.)

The employment assistance ordered under the scheme will be cancelled if and when the Government find out that there was suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding the application or during the course of enquiry conducted by Kerala water Authority.

The candidate is also informed that Kerala Water Authority has decided to make applicable Government Orders vide G.O (P)No.20/2013 Fin. dated 07.01.2013 regarding the new pension scheme in Kerala Water Authority with effect from 01.04.2013 which shall be applicable to all appointments made thereafter.
