ORDER

In the wake of negative impact on resources of Central & State Governments due to COVID -19 pandemic, Ministry of Finance, Government of India had allowed additional borrowing of 2% (including 1% unconditional borrowing) of GSDP to the States for the financial year 2020-21 subject to the implementation of following four State level reforms as per letter read above.

- a. Implementation of One Nation One Ration Card System;
- b. Ease of doing business reform;
- c. Urban Local body/ utility reforms (reforms for Strengthening Local Bodies); and
- d. Power Sector Reforms.

2. As per the reforms for Strengthening Local Bodies, the State will have to notify floor rates of user charges in respect of the provision of water-supply, drainage and sewerage which reflect current costs/ past inflation.

3. Accordingly, Government hereby notify the existing water charges including Sewerage charges, as ordered vide the G.Os read above and appended to this Order, as floor rates with 5% annual increase from next financial year onwards for all categories as part of implementing reforms in this sector.

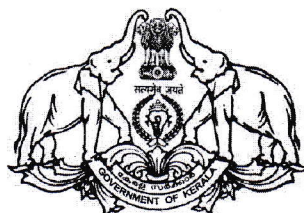

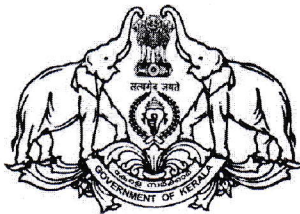
