The tenders shall be submitted electronically to the **Assistant Executive Engineer, Water Supply Subdivision, Aruvikkara, Thiruvananthapuram 695564** in the method available at the web site [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). Tenders/ bids shall be accepted only through online mode on the website and no manual submission of the same shall be entertained. All documents shall be submitted electronically by uploading before the due date mentioned above. The original /attested copy of all the documents shall be produced within **three days** of opening of the tender.

For uploading the tender documents, the tenderer has to remit the amount towards tender fee as well as the prescribed EMD through online payment mechanism for e-procurement system of Govt. of Kerala.
