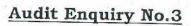

PART I

INTRODUCTION

Internal audit of P.H.Circle , Kottayam was conducted during the period from 24/01/2018 to 31/01/2018 covering the period from 01/04/2012 to 31/03/2017. On verification of the registers and files following remarks are offered.

Internal control mechanism

The internal control mechanism is not satisfactory for the following reasons. Mandatory certificate of number of pages is not authenticated in the registers. Unauthenticated entries are seen in registers. Reconciliation of bank account is not done in proper form.

Cheque Memo Register

Mandatory certificate regarding the number of pages is not authenticated.

Several entries of Cheque issued are not seen by A O or PA to SE Or SE

For eg. Ch. No. 84876 dated 13/08/2014 issued to Sri. Thomas Paul, Contractor.

Ch. No. 84908 dated 22/092014 issued to Sri. C K Mammen, Contractor.

Ch. No. 84909 dated 22/092014 issued to Sri. Sivaprasad, Contractor

Ch. No. 84910 dated 22/092014 issued to Sri. Paulose Abraham, Contractor

Corrections using whitner and overwriting are seen in the registers which are to be avoided.

II. Cash Book

Mandatory certificate is not authenticated. Regular practice of entering the monthly abstract certificate of cash balance ,entering the signature of the writer of the cash book , signature of the other person who verify the cash book, is not seen from 01/214 to 01/2015.

III. EMD Register/ Security Deposit Register

- A. Mandatory certificate is not written.
- B. The EMD /SD are released without the signature of the contractor as a token of receipt of the same.

For eg. Agreement No.5/SE/PHCK/2011-12 SD is noted as released on 10/09/2013 but signature of the receipiant is not seen in the register. (Post Office savings bank a/c No.9421 dated01/08/2011 for 1,00,000/- from M.J.Thomas.) It may be stated whether the SD is still remaining in the office otherwise state the reason for not acknowledging the receipt of the same may be reported to audit.

Similar is the case with the EMD of tender No. 47/SE/PHCK/2011-12,50/SE/PHCK/2011-12of M/s Nirman Electricals, Thiruvananthapuram.(DD No.174222 dated 21/02/2012 for Rs.46,725/-; DD No.174223 dated 21/02/2012 for Rs.1,13,700/-of SBT Ettumanoor). It is noted as released on 12/06/2012but contractor has not signed in the register.

Tender No 107/SE/PHCK/2011-12 Bank Cheque NO.147537 dated 19/3/2012 of SBT Civil Station, Kottayam for Rs.77451/-from M/s. Nirman Electricals, Thiruvananthapuram, is also released on 25/09/2012 as signed by SE, but not signed by the contractor.

C. 2 Numbers of EMDs are given to the contractors without approval of the Head of Office as per register.

Tender No.19/2010-11 for RS.50,000/-of Sri. Jerry Thomas.

Tender No.20/2011-12 for Rs.33,000/- of Sri. Jerry Thomas . Only a sign of the contractor is seen no date of release or released entry or authentication. Reason for this may be reported to audit.

- D. 7 numbers of **EMD**s of 2010 to 2012 are not released as per register, and kept in the office without forfeiting. List attached separately.
- E. Security Deposits for the period from 1979-80 are still remaining without forfeiting as per the register. These are to be forfeited and the amount may be remitted into Non Operative account with intimation to audit.

IV. Trial Balance

As per the trial balance of 3/2017 Rs.995/- is seen as debit balance in 1532 code and RS.10653/- in 1659 code. But as per the concerned registers balance in theses account codes are NIL. Hence the same may be corrected with proper entries as report to audit.

V. Treasury Account

The treasury account No. 573 and 621 are seen closed and amount Rs.98802/and Rs. 621/- respectively are credited into SB account. These amount are to be remitted into Non Operative account. This may be done and report to audit.

VI. Bank Reconciliation

In the List D of reconciliation of the SB A/c. Rs.1000/- vide Ch. No. 054107 dated 30/03/2007 and Rs.882/- vide C. No. 354606 dated 17/06/2010 are seen. Since these are not cashed yet, the amount may be credited back into the SB A/c Cheque Memo Register and fact reported to audit.

VII. Service Book

The latest residential address may be entered in all service books.

The photo in the Service Book may be substituted by new one on completion of every 10 years of service. GPF account number may be recorded in the space provided for it and the entry may be authenticated. The Earned Leave for the first year of service may be recasted @1/11 of the duty days on completion of three years of service. The same is not seen done in several service books. These may be done in the service books if not already done.

WORKS

Severe Irregularity

Non claiming of Rs.3,34,27,331/- towards DPR charge from Municipality.

This office ,initially, has been carried out 10 numbers of UIDSSMT aided work for Kottayam, Thiruvalla, Changanassery and Alappuzha Municipalities. Later all above works were handed over to Alappuzha circle when it formed. As per GCC clause, 1.5% of the estimate cost of works could be claimed by the KWA towards DPR preparation charge. As such an amount of Rs.3,34,27,331/- should have been claimed . But this office has not taken any earnest effort for claiming the above amount which is highly irregular and a great lapse. So the concerned officers may be held responsible for the loss incurred to KWA and the Superintending Engineer may be replied with specific remarks to Audit.
