#### Order

Vide reference to 1 cited above, the tariff of Guest Houses/ Inspection Bungalows of KWA was revised. An agenda note was placed before the Board for ratification of the same. Based on the representations received from various employees staying in Guest House for reducing the tariff of Guest House, an Additional Note to the Board was also placed before the 412<sup>th</sup> meeting of the Authority held on 27/01/2020 for consideration.

Vide reference cited 2 above, the Authority noted the additional note placed before the Authority with regard to providing concessional rates to the employees of Kerala Water Authority occupying the Guest House/ Inspection Bungalows of Kerala Water Authority. The Authority resolved to approve the following changes to the orders of the Managing Director dated 04.01.2020 revising the tariff of Guest House/Inspection Bungalows of Kerala Water Authority.

- (i) The Kerala Water Authority and Water Resources Department Staff on official duty at their headquarters/outside headquarters are eligible for accommodation at 1/3rd of the normal rent. Additional amount of Rs.50/day will be charged for air conditioned rooms.
- (ii) The Kerala Water Authority and Water Resources Department Staff on Private tour are eligible for accommodation at 50% of the normal rent.
- (iii) Officers/Staffs upon posting to a station can avail Guest House accommodation only for 30 continuous initial days at concessional rates under (i), i.e, 1/3rd daily normal rent. Beyond that stay shall be permitted only on forfeiting HRA of that month. Normally only 5 days of the consecutive stay will be allowed in a calendar month, sixth day only by the personal orders of the Managing Director. Any stay beyond 15 days should be with the approval of the Authority.

In these circumstances, the orders of the Managing Director dated 04.01.2020 referred 1 above,revising the tariff of Guest Houses/ Inspection Bungalows of Kerala Water Authority is revised as follows with immediate effect.

1	Dormitory/Bed	500/-
2	Non A/C Double Room	600/-
3	A/C Double Room	1000/-
.4	Suite Rooms Non A/C	1500/-
5	Suite Rooms A/C	2000/-
6	Additional Bed	150/-

The above rates are excluding taxes and GST will be applicable as per the prevailing rates

### Note:

- (i) The Kerala Water Authority and Water Resources Department Staff on official duty at their headquarters/outside headquarters are eligible for accommodation at 1/3rd of the normal rent. Additional amount of Rs.50/day will be charged for air conditioned rooms.
- (ii) The Kerala Water Authority and Water Resources Department Staff on Private tour are eligible for accommodation at 50% of the normal rent.
- (iii) Officers/Staffs upon posting to a station can avail Guest House accommodation only for 30 continuous initial days at concessional rates under (i), i.e. 1/3rd daily normal rent. Beyond that, stay shall be permitted only on forfeiting HRA of that month. Normally only 5 days of the consecutive stay will be allowed in a calendar month, sixth day only by the personal orders of the Managing Director. Any stay beyond 15 days should be with the approval of the Authority.

All other norms for allotment and maintenance of rooms will be as per existing guidelines.
