One time registration is valid for all tenders. Enrolled contractors can download the bid documents from the website free of cost. The tender fee needs to be paid at the submission of bid only. The remittance of tender fee and bid security (EMD) is by online payment through credit card/net banking. Once the payment transaction is successful, the bidder will get a transaction reference number which has to be retained by him. Unless the tender cost and bid payments are made successfully, the submission of tender will not be possible.
