9	Pre-Qualification Approval	Special Committee at Chief Engineer's Office: The Committee will consist of CE-Chairperson, DCE & AO/FO of CE's Office as members. Concerned SE will also be member of the committee. Any clarification required shall be sought before finalizing pre-qualification. Clarifications, if any, need be sought only on information already submitted. Once pre-qualification is finalized provisionally by the Committee, The Tender inviting Authority shall issue pre-qualification proceedings (provisional) in a speaking manner (explicitly stating the reasons for disqualification if any) and e-mail it to all the bidders (and not publish in the tender website for the time-being). In case of any objection/complaint regarding pre-qualification, the bidder shall have the opportunity to represent the same through e-mail to the tendering authority within 2 working days from the date of communication of the decision on pre-qualification. The final approval of pre-qualification by the Committee shall be done only after giving due consideration to the complaint if any. The bidders may be heard, if necessary. After due consideration of complaints, the Tender inviting Authority shall issue pre-qualification proceedings (final) and publish the same in the tender website, within 7 working days in the normal course, before opening the price-bid. However, if no complaints are received within 2 working days after e-mailing provisional pre-qualification proceedings, the final pre-qualification proceedings shall be published in the tender website on the third working day and the price-bid shall be opened on the fourth working day (2 days allowed for complaint submitting on pre - qualification decision is not required in the case where all tenderers are pre-qualified or in a single tender in which the tenderer is pre-			



		qualified). Pre-qualification once approved by the Committee will be final, in the normal course. The Committee shall also verify and certify that the subject tender is in order with respect to AS, TS, Estimate sanction, NIT, Scope of work and Pre-qualification, so that L1 bid can be considered for approval subject to tender sanction limit. A check list to this effect, signed by the committee shall be attached along with the tender documents submitted for approval. The check list once verified and approved by the Committee will be considered as final.
