The Superintending Engineer, P.H Circle, Kerala Water Authority, Kozhikode invites sealed competitive electronic tenders in TWO level system for the following work from Registered Class A contractors of Kerala Water Authority or contractors Registered in other departments in Kerala State / in other states in India/ in equivalent class and manufacturers eligible for A class license from Kerala Water Authority/reputed contracting firms in India. The tenderers shall have experience in implementing similar works. **The selection process will be based on Quality and Cost Based Selection (QCBS) method for projects greater than Rs.5 crores as per Board Resolution No.11141 dated 23/02/2021.**

Unless the tender cost and bid payments are made successfully, the submission of tender will not be possible.
