#### **ORDER**

The Government, vide Order read 4<sup>th</sup> above, enhanced the ratio of by transfer appointment of Lower Division Clerks from 5% to 10% which shall be reserved for the qualified service personnel working in any of the lower categories included under Kerala Water Authority (Administrative, Ministerial and Last Grade), Service Rules, 2011 or KWA Public Health Engineering Services Rules / KWA Technical Special Rules based on their seniority in the lower post for by transfer appointment at the level of KWA.

As per read 5<sup>th</sup> cited published a provisional seniority list of Last Grade Servants who acquired degree qualification and published in the web site of KWA on 06.01.2022. In the mean time as per WP (C) No. 1391 of 2022 Sri. Joshy P J., now working as Meter Reader and as per WP(C) No.2718/2022 Sri. Manilal D., now working as Driver Grade I filed suit before the Hon`ble High Court of Kerala that to include their name in the seniority list of the lower categories who acquired Degree qualification to be promoted as Lower Division Clerk.

In both the cases the petitioners belongs to Class III Category, i.e. Meter Reader and Driver Grade I. Lower Division Clerk is also Class III Category. Hence both the petitioners belong to same category and they have no claim as lower category and lower post.



As per reference 6th cited Hon`ble High Court of Kerala issued Order in WP(C) No.1391/2022 dated, 28.01.2022 that promotion to the post of LDC, if any effected, in the meanwhile shall be, without prejudice to the petitioner`s contentions raised in this writ petition and depending on the final outcome of this writ petition.

In the circumstances provisional promotion of By transfer appointment of Last Grade Servants as Lower Division Clerks at the level of Kerala Water Authority subject to the final verdict in all the pending cases before the Hon`ble High Court of Kerala.

At present KWA is having 511 sanctioned posts of Lower Division Clerks, since vide Government Order read 4<sup>th</sup> above enhanced the ratio of 5% to 10%, a total of 51 post are to be earmarked for this method of appointment. Now 25 incumbents are holding the above said promotion balance from 26 posts 25 posts are to be filled on provisional basis subject to the disposal of pending case before the Hon`ble High Court of Kerala.

Based on the above, the under mentioned qualified Last Grade Servants, eligible for appointment by transfer at the level of KWA as Lower Division Clerk are hereby provisionally appointed by transfer appointment in the level of Kerala water Authority as Lower Division Clerks in the scale of pay of Rs. 20100 - 53300/- subject to the disposal of all pending cases before the Hon`ble High Court of Kerala. They are provisionally promoted and posted to the offices noted against their names in the existing vacancies.
