The tenders shall be submitted electronically to the Superintending Engineer, P.H Circle, Kollam, in the method available at the web site <u>www.etenders.kerala.gov.in</u>. Tenders/ bids shall be accepted only through online mode on the website and no manual submission of the same shall be entertained. All documents shall be submitted electronically by uploading before 2.00 PM on 06.04.2022. The original /attested copy of all the documents shall be produced within three days from the submission of the tender.

The tenderers can view / download the tender notice and other tender documents, free of cost from the website. Intending renderers may enroll themselves for e-tendering in the website <u>www.etenders.kerala.gov.in</u>. One time registration is valid for all KWA tenders. The contractors who are registered for e-tendering and have valid password can only view / download the Tender Documents. For uploading the tender documents, the renderer has to remit the amount towards cost of tender documents as well as the prescribed EMD through online payment mechanism for e-procurement system of Govt. of Kerala.
