Bidders are advised to visit the "Downloads" section of e-Procurement website ([www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)) for detailed instructions on making online payment using internet banking facility of SBI or by using NEFT facility. The tenders shall be submitted electronically to the



Assistant Executive Engineer, P H Sub Division, Kollam, in the method available at the web site [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). Tenders/ bids shall be accepted only through online mode on the website and no manual submission of the same shall be entertained. All documents shall be submitted electronically by uploading before **04.00 PM on.12.05.2022**. The original /attested copy of all the documents shall be produced within three days of opening of the tender.

The tenderers can view / download the tender notice and other tender documents, free of cost from the website. Intending tenderers may enroll themselves for e-tendering in the website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). One time registration is valid for all KWA tenders. The contractors who are registered for e-tendering and have valid password can only view / download the Tender Documents. The Tender Schedule shall be filled up in the prescribed format provided in tender document. For uploading the tender documents, the tenderer has to remit the amount towards cost of tender documents as well as the prescribed EMD through online payment mechanism for e-procurement system of Govt. of Kerala. Only those tender schedules which are downloaded from the website only will be considered.

Preliminary agreement in the prescribed form in `200/- Kerala Stamp paper duly signed and sealed shall be uploaded without fail.

The tenders will be opened by the Assistant Executive Engineer, P H Sub Division, Kollam/ Authority at the time of opening.
