The Kerala Water Authority is a Statutory Body constituted under section 3 (1) of the Kerala Water Supply and Sewerage Act, 1986.

As per Appendix-A II 2 of the Regulations made under the said Act which is read above, the Executive Engineer is responsible for the proper maintenance and upkeep of all installations and structures under the maintenance charge of the Divisions. He is also assigned with the duty to inspect by himself the installations and structures systematically and carefully or through his subordinates particularly vulnerable portions thereof like pump houses, reservoir, treatment plants, pipe lines, etc. These installations, structures, pump houses, reservoir, treatment plants, pipe lines, etc. inter alia constitute the Assets of the Kerala Water Authority as provided under rule 2 (b) of the Kerala Water Authority (Depreciation, Reserve and its Utilisation) Rules, 1992.

In the above circumstances, in extension of the duties conferred upon the **Executive Engineers** of the the Kerala Water Authority in the Division concerned as provided under Appendix-A II 2 of the Kerala Water Authority (Duties of Employees) Regulations, 1999, **the Executive Engineers of the concerned Divisions are hereby designated as the Estate Officers of the Kerala Water Authority.**

The Executive Engineers so designated shall carefully upkeep and properly and diligently maintain all the Assets of the Kerala Water Authority as defined under rule 2 (b) of the Kerala Water Authority (Depreciation, Reserve and its Utilisation) Rules, 1992 and shall maintain an Assets Register as provided under rule 3 of the said Rules with updated asset status.

This order shall be published in the official website of the Kerala Water Authority and shall be served on all Executive Engineers in the Divisions for information and compliance.
