The 4 new MVS proposals (under Kottayam District) pending approval of SWSM Apex committee were placed before DWSM for reappraisal. The Kottayam DWSM meeting held on 29/04/2022, 10/08/2022, and 26/08/2022 reappraised the proposals and decided that in the case of the 4 schemes (44973 FHTCs), the proposals already approved by SLSSC dated 31/12/2021 are optimal and need no further revision in the proposal.

However, the cost of the scheme increased due to the revision of GST rate from 12% to 18% and the revision of rates of pipes in SOR. Also, FHTCs under 2 small proposals in



Kadanadu and Ramapuram Panchayats (851 & 1106 FHTCs respectively) are clubbed to the comprehensive scheme covering 13 panchayats which includes the above panchayats.

The detailed scheme wise and Panchayat wise list of the reappraised proposals is attached as Annexure II.

There is increase in amount to Rs.125.46 crores which is due to the revision of GST rate from 12% to 18% and highly undulating areas requires additional boosting to ensure continuous supply of drinking water.

The detailed list of reappraised proposals approved by DWSM is appended as Annexure-II.

Decision:

After detailed discussion, the 6th SWSM Apex Committee decided to approve 2 nos of reappraised proposals submitted by DWSM committee to provide 44973 Nos, of FHTCs for an amount of Rs.1251.63 crores as per the list appended as Annexure - II.

Agenda No. 2: Proposal requesting the issue of a special order by the Government for enhancing the rate for negotiated purchase of private land by the Grama Panchayath for the Implementation of the JJM Project as in the case of Power Grid project.

The main issue related to the implementation of the JJM scheme is the delay in the acquisition of private land for the execution of project components. Land acquisition in the case of Private land is facing issues related to the rate. As the market value is greater than the fare value, the Panchayats are facing difficulty to acquire private lands. As a solution to this, DWSM, Kottayam has put forward a suggestion requesting to issue special Govt order to enhance the rate for the purchase of Private land as done in the case of Power Grid Project (GO (MS) No. 29/205/PD dt. 30/07/2015). The detailed proposal of DWSM, Kottayam regarding the same is appended as Annexure 3. The proposal is placed before the 6th SWSM Apex committee for discussion and for submitting the proposal to Government for consideration and approval.

Decision:

6th SWSM Apex decided to place it before the SWSM Executive Committee before it is brought to apex committee.
