Order

Government as per read (1) cited above, directed to pre-qualify and publish a list of qualified suppliers / manufacturers based on requirements and guidelines of Kerala Water Authority with direction that the list of qualified suppliers / manufactures (Vendor List) along with the rates, after an extensive market study, duly verified and certified by Kerala Water Authority shall be submitted to Government for approval. It was also directed to include the list of pre-qualified suppliers and manufacturers in the NIT for works for procurement of pipes and allied items, for ensuring the specification and quality of items supplied.



Subsequently, Expression of Interests were called for the empanelment of Pipes & specials, Valves, pumps, motors, starters, transformers, water meters and flow meters and lists of qualified vendors were published vide read (5), (6) and (7). Also, the Technical Committee held on 28-05-2022 had decided to invite Expression of Interest again separately for each products with revised eligibility criteria, for getting more participation of the firms.

Accordingly, bid conditions were modified and fresh Expression of Interests were invited for Empanelment of Manufacturers of Pipes & specials, Valves, pumps, motors, starters, transformers, water meters and flow meters separately. Among which, the tender for the empanelment of pipes, specials and valves was invited as mentioned in read (2) and (3). The EoI document was published in the Government of Kerala e-tender website on 13-06-2022 with due date on 27-06-2022 at 3.00 pm. The pre-bid meeting was scheduled on 20-06-2022, but no firms participated in it. Hence the due date was further extended three times for getting sufficient number of participants.

Twenty (20) firms participated in the tender through e-tender portal. List of bidders attached as Annexure II. Documents received thus were verified and placed before the evaluation committee held on 03-12-2022. The committee examined all details and recommended to empanel the following firms for the supply of various types of pipes, specials and valves to Kerala Water Authority. The committee also suggested to collect latest budgetary offers from already empanelled manufactures for updating existing SoR.

In the above circumstances, the following firms are also empanelled herewith for the supply of various types of pipes, specials and valves to Kerala Water Authority, along with the firms already empanelled vide read (5).

Terms and Conditions

- 1 The empanelment is valid for a period of 2 years.
- 2 All the Empaneled Manufacturers should renew their Registration on expiry of the period of current validity. The fee for renewal is fixed at ₹ 2,500 for each group. Extended validity of this empanelment will be expired till a new empaneled list is approved by Kerala Water Authority.
- 3 The Manufacturers shall execute an agreement in Kerala Stamp Paper worth ₹ 200 with Chief Engineer (HRD&GL) for the due fulfillment of registration as approved suppliers of Kerala Water Authority.
- 4 The empanelment will remain in force subject to renewal of license allotted by BIS, where ever applicable, and shall be furnished to this office on time to time duly attested.
- 5 In case, Manufacturer fails to supply the said products for any works of Kerala Water Authority within the validity period of this empanelment list, its Empanelment will be cancelled.
- 6 During validity period of this Empanelment Certificate, if any document submitted by the manufacturer for empanelment is found false or blacklisted / debarred by any other competent authority it will result in revocation of this enlistment certificate will lead to black listing of manufacturer.
- 7 The materials from the prequalified Manufacturers will only be accepted by Kerala Water Authority.
- 8 This order form part of NIT document and shall be uploaded along with NIT for tenders.
- 9 The registration does not guarantee the award of contract. KWA shall invite tenders for the works and the pre-qualified manufactures can participate in the tender either directly if they are qualified for the bid or through an MoU with any one of the qualified bidders for the works. Responsibilities for the tender submitted by their authorized dealers for the performances and guarantee of the product supplied vests with the Manufacturers also.
- 10 The manufacturers shall notify any change in address mentioned in the shortlist as soon as the change take place to the Managing Director and Chief Engineer (HRD&GL).
- 11 The products supplied by the vendors should conform with the latest relevant IS specifications.
- 12 Empanelled manufacturer shall provide budgetary offer or any other relevant documents (IS Certificate, Experience Certificate etc.) as required by KWA from time to time.
