B Other Audit Findings

I Non Crediting of time barred /unclaimed securities & EMDs as revenue to KWA

As per para 15.4.1(iii) of the KPWA Code, balance amount unclaimed for more than three years should be credited to the revenue as lapsed deposit. On verification of Security deposit and EMD Registers showed that Security Deposits received by PH Circle Kollam in the form of FDRs, NSC ,KVP, Post office TD etc were not credited as lapsed deposits even after the expiry of stipulated period of three years.

Non initiation of timely action to credit the lapsed deposits to the Revenue account resulted in the loss of revenue amounting to ₹157lakh.

Though the validity period of the securities had expired, no action was seen initiated by the controlling officers either to renew/release/forfeit the deposit documents. Periodical physical verification should be conducted at regular intervals to avoid the lapse mentioned above. The following security documents are found time barred and unclaimed

II Release of Security Deposit -Undue benefit to the Contractor

On verification of the Security deposit register, it is noticed that some of the security deposits were released by substituting with new one. On further verification the SDs were pretty old as of 2012-13. The present status of the work/gurarantee period is also not seen reported. If liability is existing against the contractor, the SDs could have been forfeited instead of substituting the same. If these were forfeited, the amount with upto date interest can be credited to NOA. The circumstances under which substitution effected and the present status of the guarantee period of the work may be reported.

III. Trial Balance for 3/2022

On verification of the trial balance for the period from 04/2012 to 3/2022 is observed that following heads are showing huge amount as credit/debit balances. These head of accounts are third party payable accounts in which all the amounts received, should be paid to the respective agencies/departments. The errors may be rectified and fact reported to audit.

2825 (LIC/SLI)

An amount of Rs. 10128/- is seen as debit balance. The reason for remitting the premium without effecting/recording recovery may be intimated to audit.

2829 (other statutary employees deduction)

An amount of 21995/ is showing as credit balance. The reason for keeping the amount in the account may be explained.

2834 (ST on Tender sales)

Rs.377617/- is showing as debit balance in this account. This may be verified and reported.

2843 (TDS from employees)

Rs.62192/- is showing as debit balance in this account. The reason for the missing credit entry may be explained

9139 (Contra)

An amount of Rs133755/- is showing as credit balance in this account. This may be verified, rectified and reported

9219 (Control A/c. Capital))

An amount of Rs.3942/- is showing as credit balance in this account. This may be verified and necessary journal entry may passed and fact reported.

IV Non settlement of Imprest Advance.

As per Imprest register, closing balance for 02/2021 shown as Nil, but in trial balance for 03/2021 the closing balance of '1532' is ₹2500/-. Also in 02/2022, an amount of ₹2500/- seen settled in imprest advance register as on 16/02/2022. But the entries in cash book corresponding to the settlement of imprest advance recorded on 05/2022. The entries made in the cash book should be in accordance with the entries recorded in the imprest advance register. This may be corrected and intimated to Audit. Further an amount of ₹2500 is remain unsettled for a long period. This may also be verified and the details of the responsible officers may be intimated.

V Non renewal of Bank Guarantee.

On verification of Bank Guarantee details it is seen that the validity of following BGs had expired and were not revalidated.

As per Bank Guarantee Rules the bank is liable to pay the guarantee and only if a demand or a claim is lodged with the bank in writing on or before the expiry date of the bank guarantee. All rights under the guarantee shall be forfeited after the expiry of the validity, and the bank shall be relieved and discharged from all liability if no claim is made within the validity period.

Due to the non renewal of Bank Guarantee within the time limit stipulated by bank authorities, Kerala Water Authority stands at the risk of losing the Bank Guarantee amount if the contractor leaves the work in midway. Division replied that timely action to renew the BGs were taken .However the details of renewal of the said BGs may be intimated to the audit.

VI. Non imposing of fine for belated execution of Agreement

The selection notice of the above said work was issued on 13.07.2022 with a direction to execute the agreement within 14 days on receipt of information .But on verification of the agreement, it is noticed that the agreement is executed 29.12.2022 which is five months and 16 days after the issuance of the selection notice. The reason for delay in execution of the agreement and the details of fine imposed is not available in the agreement. It is replied that the fine has been imposed to the contractor for the belated execution of Agreement. However the details of imposition and recovery details of the fine may be reported.

VII Non demanding of sufficient Additional Performance Guarantee and non imposition of fine

Name of work: JJM Veliyam Panchayath Phase I- Part II-Balance work for pipeline extension and JICA

The subject work was arranged with tendered PAC of ₹1,94,44,396/-. In response to the tender call, Out of the five offers received, the lowest offer is from Satheeshkumar T at ₹1,37,41,778/-which is a 29.33% below TPAC. The selection notice issued to the lowest bidder at his quoted amount. But on verification of the Agreement, it is noticed that the Additional Performance Guarantee required as per the NIT condition is not demanded while issuing the work order. It is a mandatory requirement as per NIT. In this connection the following points may be clarified.

- 1. Reason for non inclusion of APG in the selection notice
- 2. Recovery details of fine imposed for delay in executing Agt.

It is replied that the contractor has obtained a Judgement in his favour dated 19.08.2022 to avail exemption of Additional PG and the selection notice is attached with the copy of the Judgement . Considering this, sub para 1 is not pursued further. The recovery details of fine imposed for delay in executing the agreement may be furnished to audit.



VIII. Irregular sanctioning of Medical Reimbursement.

On verification of the medical reimbursement bills and vouchers to find out whether the bills were admitted/passed in compliance with the Circular No. KWA/HO/E11-6207/2015 dated 29.11.2019 of the Managing Director, grave malpractices were noticed. Most of the bills were passed without observing the Rules and admitted for fake bills

The Circular contained instructions to regulate the malpractices in claiming medical reimbursement using medical prescriptions issued by a particular doctor and the cash bills from a particular institution especially in the case of treatment under Ayurvedic system. Instructions were issued through the Circular regarding the admissibility of the medical bills. This resulted in the irregular sanctioning of ₹1.95 lakhs

reimbursement shall attract disciplinary action against the claimant and upon notice of such incident, the claimant shall be liable to remit the amount with interest of such claim to the Authority .Immediate action may be taken to recover the amount as per Rules and intimated.

On verification of the Service Book of Sri. Surfaras. A, U. D. Clerk the following discrepancies were noted.

- 1. The incumbent had avalied E/L for 43 days from 19/05/2007 to 30/06/2007 but in earned leave account, (page No. 112 of S. B) the period in days wrongly calculated upto 31/07/2007 instead of up to 18/05/2007. This should be corrected and reported to audit.
- 2. The wrong entry in E/L account (page No 114) for the period from 30/06/2007 may also corrected and intimated
- 3. It is also noted that entries regarding the extension of LWA sanctioned to the incumbent for the period from 03/07/2012 and 03/07/2017 not seen recorded in the LWA leave account (page No. 132) of the incumbent. This should be updated and reported.
