ORDER

Group Health Insurance Scheme for the Kerala Water Authority (KWA) employees and their dependents was started in 2014 and is being continued. The existing TAILOR MADE GROUP HEALTH-POLICY is with M/s. United India Insurance Company Ltd., 0906022820P101792147, period of insurance being from 00:00 hrs on 16.04.2020 to Trichy-620018, Tamil 74-A,

The existing Insurance policy expires on 15.04.2021 midnight. As such, the existing midnight on 15.04.2021. medical services policy for the benefit of employees of KWA is to be renewed before the due date. In this connection, a meeting was conducted with the representatives of the recognized Trade Unions on 29.01.2021 at 11.00 AM. In the meeting, it was decided to invite competitive quotations from Public Sector Insurance Companies (Government of India) and IRDA Registered Insurance brokers for the renewal of GHIS. This was in light of the decision of the KWA Board directing to explore the possibility of including Brokers as well..

Accordingly, competitive quotations were invited by this office vide reference 2 nd cited above for insurance coverage of Rs.3 lakh (Rupees Three lakh only) fixing last date of receipt as on 25.03.2021. In response to this, three insurance companies submitted their offers on 25.03.2021. The quotations were opened on 25.03.2021 at 3.30PM and the details of the quotes are as given below:

1. M/s. The Oriental Insurance Company Ltd, Trivandrum

2. M/s United India Insurance Company Ltd – Trichy

It is seen that the lowest quote in all respects (L1) is received from M/s. United India Insurance Company Ltd, Trichy. The firm has quoted an amount of Rs.14,99,12,806/- including G.S.T (i.e Rs.12,70,44,751+ GST Rs.2,28,68,055) for 7,000 employees and 28,000 dependents. The annual premium per head works out to Rs.21,416.12/- (Rupees Twenty One Thousand Four Hundred and Sixteen decimal point one two only) .

In order to arrive at a decision on the matter, a meeting was held with the representatives of recognized Trade Unions on 30.03.2021. In the meeting, it was unanimously demanded for exploring the possibility of getting the policy amount reduced to a reasonable extent and to get additional offers from the firm. Accordingly, a letter of negotiation was sent to the lowest quoted firm as per the terms mentioned the quotation notice. Later, a meeting was held with the firm on 07.04.2021. In the meeting, the firm's representative justified the quoted rates and requested to exempt the in-laws from the dependent's category for reducing the premium. This was not accepted as it will amount to variation in conditions in the original quotation notice. The firm agreed to consider a deduction if KWA can accept with 20% co-payment in the case of claims of in-laws. The meeting was concluded with request to reduce the premium further and to forward the offer as suggested.



The firm, as per the paper (7) read above, has informed that the premium cannot be reduced. However, they forwarded a counter offer of reduced premium with 20% co-payment on in-laws as detailed below:

The total reduction in the premium offered by the L1 bidder with 20% co-payment on in-laws claim is Rs.25,65,722/- only. (ie.,Rs.14,99,12,806 minus Rs.14,73,47,084 = Rs.25,65,722/-).

It is seen that when negotiated with L1 for reduction of premium, the company made a counter offer to remit 20% co-payment for in-law's claim which was not mentioned in the original offer. If 20% co-payment is made they are prepared to reduce the total premium by Rs.25,65,722./-. If the counter offer is accepted, it would invite unwarranted dispute from other two participants as for the provision for 20% co-payment, they were not given the chance to quote. As such the counter offer is not acceptable and the existing scheme which covers employees and their dependent parents or dependent in laws as in previous year shall continue at their first quoted rate of Rs.14.99 crore.

The total number of employees as per strength of staff of KWA, is worked out as 6750. The total premium amount for a total of 6750 employees at the lowest quoted rate comes to Rs.14,45,58,810.00 (Rupees Fourteen Crore, Forty-five Lakhs, Fifty-eight Thousand Eight Hundred and Ten Only). (i.e., Net premium + GST 18%).

The special condition in respect of the policy are:

- 1. The premium for one year will be released in two equal installments
- First installment will be released to the company for the first six months at the policy and the inception. Policy will be commenced immediately with the available insured persons.
- 3. Second installment of the premium will be paid to the company at the end of the sixth month .

As per the above proposal for renewal of Group Health Insurance Scheme for Employees of Kerala Water Authority for the year 2021-2022 with M/s. United India Insurance Company Ltd., with the existing conditions for 6750 number of employees and their dependents, an annual premium of Rs.21,416.12 (Rupees Twenty One Thousand, Four Hundred and sixteen, decimal point One, two Only) rounded, including 18 % GST, the total amount comes to Rs.14,45,58,810.00 /- (Rupees Fourteen Crore, Forty five Lakhs, Fifty eight Thousand Eight Hundred and Ten Only). The actual number of families is variable as some newly recruited hands are expected to join



soon. The premium for the actual number of employees covered will be paid/refunded in due course.

Under these circumstances, the offer of M/s. United India Insurance Company Ltd., Trichy for renewal of GHIS of employees of KWA for the year 2021-2022 with the same terms and conditions for an annual premium of Rs.21,416.12/- (Rupees Twenty One Thousand and Four Hundred and Sixteen and Paise twelve) including GST @ 18% per employee for 6750 employees and their dependents , amounting to Rs.14,45,58,810.00/- (Rupees Fourteen Crore, Forty-five Lakhs, Fifty eight Thousand and Eight Hundred and Ten Only). inclusive of GST is hereby provisionally accepted and sanction is hereby accorded to release an amount of Rs.7,22,79,405/- (Rupees Seven Crore, Twenty two Lakhs, Seventy Nine Thousand, Four Hundred and Five) in advance to the firm as first installment. The payment is made subject to the condition that depending upon the number of employees covered, the variation in premium will be either collected or refunded during payment of the second installment. Also, in case an insured person dies during the currency of the policy without making any claim, the premium will be proportionately refunded or settled.
