O R D E R

In the circumstances reported by the Managing Director, Kerala Water Authority in his letter reproduced as second paper above, Government are pleased to convey its approval to the Kerala Water Authority under the proviso to clause (iii) of sub-section (2) of Section 15 of the Kerala Water Supply and Sewerage Act, 1986 for revision of water tariff, now being levied by the Authority from the domestic, non-domestic and industrial consumers for the water supplied by the Authority from the Water Supply Schemes/Systems vested with and/or belonging to it, in its service area as under with effect from 1-4-1993:

<u>Consumption per month</u>	<u>Rate</u>
(a) Domestic Connections	
1. Up to 10,000 litres	Rs.15/- p.m. minimum charges
2. 10,000 to 30,000 litres	Rs.15.00 plus Rs.21.00 per 1000 litres in excess of 10000 litres.
3. 30,000 to 50,000 litres	Rs.55.00 plus Rs.3.00 per 1000 litres in excess of 30000 litres.
4. Above 50,000 litres	Rs.115.00 plus Rs.4.00 per 1000 litres in excess of 50000 litres.
(b) Non-domestic Connections	
1. Up to 50,000 litres	Rs.4.00 per 1000 litres Rs.50.00 minimum charges.
2. Above 50,000 litres	Rs.200.00 plus Rs.6.00 per 1000 litres in excess of 50000 litres.

(c) Industrial Connections

For entire consumption Rs.6.00 per 1000 litres,  
Rs.100.00 minimum charges.

2. Government also agree to the proposal for the automatic revision of water tariff by 15% every year from 1994 onwards.
