ORDER

In the circumstances reported by the Managing Director, Kerala Water Authority in his letter read as 4th paper above, Government are pleased to convey its approval to the Kerala Water Authority under the proviso to clause (iii) of sub-section (2) of section 15 of the Kerala Water Supply and Sewerage Act, 1986 for revision of the water tariff, now being levied by the Authority from the domestic, non-domestic and industrial consumers for the water supplied by the Authority from the water supply schemes/systems vested with and/or belonging to it, in its service area as detailed below.

Consumption per month

Rate

a) Domestic Connections

1. Upto 10,000 litres
At the rate of Rs. 2/- per kilo litre, and Rs. 20/- per month Minimum charge.
2. 10,000 to 30,000 litres
Rs. 20/- plus @ Rs. 3.00 per every 1000 litres in excess of 10,000 litres.
3. 30,000 to 50,000 litres
Rs. 80/- plus @ Rs. 5.00 per every 1000 litres in excess of 30,000 litres.
4. Above 50,000 litres
Rs. 180/- plus @ Rs. 7.35 per every 1000 litres in excess of 50,000 litres.

b) Non-Domestic Connections:-

1. Upto 50,000 litres At the rate of Rs. 7.35 per 1000 litres and Rs. 100/- Minimum charge.
2. Above 50,000 litres Minimum charge of Rs. 366/- plus @ Rs. 10.60 per every 1000 litres in excess of 50,000 litres.

c) Industrial Connections:-

For consumption in a month: @ Rs. 10.60 per 1000 litres and Rs. 200/- Minimum charge.

d) Through Street Taps:-

(Panchayat/Municipality/ Corporation) @ Rs. 2.00 per 1000 litres

These revised tariffs will take effect from 1.4.1999.
