ORDER

Vide read 1st above the Hon'ble Kayamkulam MLA Smt U Prathibha has requested Hon'ble Water Resources Minister for providing a new Division office at Kayamkulam,

considering the huge quantum of works attended by the existing Division at Alappuzha. Vide read 2nd above, the Government have endorsed the same request and directed Kerala Water Authority to explore the possibility of providing a new Division office at Kayamkulam.

The matter has been placed before the Board of Kerala Water Authority on 23.07.2021 and it was resolved a rational rearrangement of Divisional offices across the state is required, based on the number of existing connections and planned connections under JJM. Accordingly a draft rearrangement of Division offices was prepared and the same was presented before the recognized Trade Unions and other organizations representing Kerala Water Authority staffs on 05.12.2022 and 06.12.2022. The same proposal was also presented before the Chief Engineers, Superintending Engineers, and Executive Engineers during the workshop held on 25.11.2022. It was also requested to forward their recommendations regarding the proposal. Many organizations represented that such a restructuring for the entire Kerala Water Authority during the implementation of JJM works can cause unnecessary delay in the JJM works.

Accordingly the following three proposals for the formation of PH Division office at Kayamkulam , Project Division office at Kanhangad and Project Division office at Meenachal-Malankara are approved as follows.,

I. PH Division, Kayamkulam

The PH Division, Alappuzha is presently one of the largest Divisions of Kerala Water Authority catering to the entire district of Alappuzha. The Division is having more than 4 lakh numbers of water connections spanning over 5 Sub Divisions. The topographical peculiarity of Alappuzha district with longest coastal area in the state with high density of populations and flood prone areas like Kuttanadu poses great threat to the availability of safe drinking water to the public.

Alappuzha District with 9 Assembly constituencies has 72 panchayats covering 93 villages and 6 Municipalities with a population of about 22 lahks, There are 92 existing water supply schemes and there is only one regular Division in Alappuzha District. The water supply in the entire district is maintained through this Water Supply Division. Around 4 Lakh consumers are coming under PH Division, Alappuzha.

Under these circumstances, it is proposed to form a new PH Division in Kayamkulam with head quarters at Kayamkulam. The administrative control of PH Sub Division, Edathuva, Water Supply Project Sub Division Harippad and Water Supply Project Sub Division Mavelikkara are hereby attached under newly formed PH Division, Kayamkulam which can effectively manage southern parts of Alappuzha District. The details are tabled below.

II. Project Division, Kanhangad

Kasaragod District with 5 Assembly constituencies has 38 panchayats covering 128 villages and 3 Municipalities with a population of about 13,90,000. There are 79 existing water supply schemes and there is only one water supply Division in Kasaragod District. The water supply in the entire district is maintained through this Division. There is no Project Division in Kasaragod district and the new projects in Kasaragod district are now being implemented through Project Division, Kannur.

Under Jal Jeevan Mission 2.20 lakh FHTCs are to be given in Kasaragod District for which Administrative Sanction has already obtained for Rs.1744.66 Crores. Production components of the new water supply schemes sanctioned under JJM are being executed by the Project Division, Kannur. In addition, the KIIFB project for Kasaragod Municipality is also implemented by Kannur Project Division. At present, Project Sub Division, Uppala under Project Division, Kannur is assigned to implement the above said works. The works in Kasaragod district includes design & construction of 4 Nos. of WTPs of capacity varying from 5 mld to 29 mld, design & construction of 29 Nos. Service Reservoirs, laying of 2110 km pipelines, FHTCs etc. One Sub Division is inadequate for implementing such quantum of works. Hence a new Project Division in Kasaragod is essential for the timely completion of projects in Kasaragod District.

Under these circumstances it is proposed to form a new Project Division in Kanhangad with head quarters at Kanhangad. The details are mentioned below.

III. Project Division, Meenachal- Malankara

The Project Division, Kottayam is handling projects costing nearly Rs. 2520 crores covering 31 panchayaths of Kottayam district. This includes works coming under JJM costing Rs.2267.24 crores and other projects coming under heads like KIIFB, NABARD, RKI, NRDWP

etc. costing nearly ₹ 250crores. Already 53 packages of works worth Rs. 620 crores are ongoing and works costing nearly Rs.1900 crores is being arranged. Hence the formation of a new Project Division under PH Circle, Kottayam is proposed, for the execution of schemes including Malankara based JJM work.

Malankara based JJM Scheme worth ₹ 1243 crores, covers 13 panchayaths, which are at a fair distance away from the present office /headquarters. The Package for production components like construction of Raw Water intake & Raw water Pumping main and allied works at Malankara reservoir have already been tendered. Also the works for construction of 45 MLD WTP at Neelloor and allied works which is at a distance of 7.5 km from Intake is being awarded. Tender for works in distribution network including reservoirs of 13 Panchayaths are being arranged, even though the land acquisition procedures are in progress, anticipating that it would be handed over by the panchayth in due course of time.

The additional Project Divisions have been allotted to districts like Alapuzha, Ernakulam, Palakkad etc considering the geographical features and work load. It is requested to form one such additional Project Division, by rearranging/ reposting of staff from offices with lesser workload. This could help KWA in timely completion of all the ongoing projects sanctioned under all Panchayaths of Pala, Poonjar and Kanjirappally Constituencies, including JJM-Malankara Scheme.

Under these circumstances it is proposed to form Project Division Meenachal-Malankara with head quarters at Pala. The details is below mentioned.
