In exercise of the powers conferred by clause (a) of subsection (2) of section 64 of the Kerala Water Supply and Sewerage Act, 1986 (14 of 1986) and subsection (3) of section 8 thereof of, the Government of Kerala hereby make the following rules to amend the Kerala Water Authority Technical Service Rules, 2023, issued under G.O. (P) No. 1/2023/WRD dated 27th January, 2023 and published as S.R.O. No.156/2023 in the Kerala Gazette Extraordinary No. 358 dated 30th January, 2023, namely:—



## RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Water Authority Technical Service (Amendment) Rules, 2023.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Water Authority Technical Service Rules, 2023, for rule 7, the following rule shall be substituted, namely:—

“7. *Appointing Authority.*—The appointing authority in respect of categories 1 and 2 under “Engineering and other Technical Service” under rule 2 shall be the Government and the appointing authority in respect of the remaining categories shall be the Managing Director, Kerala Water Authority.”.

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have issued Kerala Water Authority Technical Service Rules, 2023 under G.O.(P) No. 1/2023/WRD dated 27th January, 2023 and published as S.R.O. No.156/2023 in the Kerala Gazette Extraordinary No.358 dated 30th January, 2023 in supersession of all existing rules and orders on the subject. As per rule 7 of the said rules, the appointing authority for all categories of posts mentioned in the rules shall be the Managing Director, Kerala Water Authority. Government have now decided to amend rule 7 to empower the Government to make appointment in respect of the categories 1 and 2 under “Engineering and other Technical Service” under rule 2.

The notification is intended to achieve the above object.
