ORDER

The Upper Monetary Limit for sanctioning Temporary Advance Non-Refundable Advance by various categories of Sanctioning authorities have been revised as per Government Order read as 3<sup>rd</sup> paper above.

Now, it has been brought to the notice of the Government that the Upper Monetary Limit specified therein in causing undue delay and inconvenience in sanctioning advances consequent on revision of pay and allowances of State Government Employees.

Government have examined the matter in detail and are pleased to revise the existing Upper Monetary Limit to various categories of Sanctioning Authorities as below for sanctioning Temporary Advance( TA) subject to a maximum of 75% of the eligible balance at credit of the subscriber, as booked by the Accountant General and also based on the statement of deposits and withdrawals in Form E:

1	Lowest Gazetted Officers/DDOs/Sub Divisional Officers	Temporary Advance	2,50,000/-
2	District Officers/ Regional Officers	Temporary Advance	5,00,000/-
5	Head of Departments	Temporary Advance	As per Rules without monetary limit

The Categorisation of Officers and Monetary Limits fixed herein shall be in supersession of all existing orders issued in the matter.

Each Head of Department shall issue an order specifying the Designation of Officers under its control to be included under the above categories and intimate the same to Government and the the Principal Accountant General (A&E) Kerala, Thiruvananthapuram.


