ORDER

As per above read 1st, The ratio of Surveyor Grade II, Surveyor Grade I and Head Surveyor will be revised to 4:4:1 with effect from 01.11.1998. The sanctioned strength of Surveyor Grade II is 70nos, Surveyor Grade I is 69nos and Head Surveyor is 17nos and the total cadre sanctioned strength is 156.

As per read 2nd and 3rd above, The 16 post of Surveyor Grade-I was de-cadre as Surveyor Grade-II for Public Service Commission appointment and the same is hereby upgraded as per rules. No resultant vacancies will arises in the category of Surveyor Grade II as the vacancies due to de-cadre was already reported to Public Service Commission.

Vide read 4th above Technical Special Rule, for the promotion of Surveyor Grade-I, the incumbent must have worked in the category of Surveyor Grade II under Kerala Water Authority

for a minimum period of 3 years.
