ORDER

Kerala Water Authority in its resolution 11134 dated 23.02.2021 (419th meeting), discussed the agenda regarding deployment of Head Operator by entrusting Supervisory Charges in connection with the Operation and Maintenance activity in pump houses and treatment plants, in continuation to various agendas, meetings and assessments done before and resolved to continue with 86 Head Operator Supervisory posts (as 86 locations identified with WTP of minimum capacity of 9 MLD) in this regards. On this basis proceedings issued vide reference 1 cited to newly entrust 43 Head Operators with supervisory charges strictly on seniority basis.

Since few incumbents informed inconvenience in taking supervisory charges as per the proceedings vide reference 1, direction issued to controlling officers from this office vide reference 2 not to relieve unwilling incumbents from

present station. At present there are 73 Head Operators working with supervisory charges. Hence 13 Head Operators are hereby entrusted with supervisory charges strictly based on seniority of Head Operator and posted to the office shown against their names.
