Water Resources Department - Formation of New Circle Office and Division Office for Kerala Water Authority at Idukki District by rearranging existing posts for administrative convenience - Orders Issued.

<u>ORDER</u>

Idukki District has two municipalities and 52 Grama Panchayaths. It has about 2,80,000 rural households, of which only 97,000 are provided with protected piped water supply schemes. Under the prestigious Jal Jeevan Mission Project, about 2 lakh households are yet to be provided with piped water supply schemes. At present, PH Circle, Muvattupuzha, is managing the implementation of all water supply schemes in Idukki. All the water supply schemes in the entire district are operated and maintained by P.H. Division, Thodupuzha.

2) The Managing Director, Kerala Water Authority, as per the letter read above, submitted a proposal for formation of a new Circle Office and Division Office at Painavu, Headquarters of Idukki District. It was also proposed to rearrange the existing posts for the formation of a new circle office and division office to reduce operational costs.

3) Government have examined the matter in detail, and by considering the peculiar geographical features, nature of the works to be attended, and easy and effective implementation of schemes, and are pleased to accord sanction for the formation of separate Circle Office and Division Office stationed at Painavu, Idukki District. In order to reduce operational costs, the necessary posts shall be relocated from the existing posts, as detailed below.

1.P.H.Circle, Idukki.

Idukki district has five Legislative Assembly constituencies, namely Thodupuzha, Devikulam, Idukki, Udumbanchola, and Peerumedu. This new circle office shall have the jurisdiction of the entire Idukki District. There will be three division offices under this office;


- 1. P.H. Division, Thodupuzha (existing)


II. P.H. Division - Thodupuzha



The Administrative Jurisdiction of Sewerage Circle, Kozhikkode will be Palakkad, Malappuram, Kozhikkode, Wayanad, Kannur and Kasargod Districts. The Administrative Control of Project Division, Perumbavoor is hereby transferred to PH Circle, Muvattupuzha.

5) Following transfers and postings are also ordered. Smt. Asha Raj N. Superintending Engineer, Sewerage, PPD and Wascon Circle, Kochi is transferred and posted as Superintending Engineer, PH Circle, Alappuzha in the existing vacancy. Sri. Shyju P. Thadathil, Superintending Engineer, Sewerage PPD and Wascon Circle, Thrissur is transferred and posted as Superintending Engineer Sewerage PPD and Wascon, Circle Kochi vice Smt. Asha Raj N. transferred.

6) The Controlling Officers are directed to relieve the incumbents in the shifted posts as per rules. The sanctioned strength of the offices concerned shall be recast accordingly by the respective Head of office. The respective Controlling Officers shall ensure compliance and make necessary arrangements for transfer of files and related works.

7) The Chief Engineer, Kochi is authorized to make all necessary arrangements for the smooth functioning of the offices. The

Administrative Wing in the Head Office shall verify the same in due course.
