The releases under humanitarian/special grounds against the special requests made by the employees the releases may be restricted under the following grounds.

- 1. Medical Grounds (illness as detailed in the para can be fully included). Illness of self, spouse, kids, parents as well as in-laws only be considered. (details enclosed)
- 2. Loan recovery cases / Financial issues Cases where Demand notice issued by Financial Institutions/Banks and the stages above after issuing demand notice by such institutions only be considered.
- 3. Release under Special categories be made once every three months so that priority for releases towards GPF Closure and others under general due can be made in a regular manner depending upon the availability of funds.
- 4. Documentary evidence shall be supported in the special requests submitted by the employee.
- 5. If the total amount towards all such special requests exceeds the monthly GPF contribution of the month in which the special release is made, the requests be restricted to the monthly contribution amount/requests be prioritized in the sequence of above
- 6. The requests which fall under the category from 1 to 2 above and have skipped as per point 5 above, be carried forward and released during the next release of special cases. The skipped requests will be given priority over the requests considered during that month.
