be submitted online only and in the designated cover(s)/ envelope(s) on the e-GP website. Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. A bid submission fee shall be remitted online during the time of bid submission.

Price Bid shall only be submitted through online. Details regarding remittance of Bid Submission Fee and Bid Security, Bid preparation and submission are mentioned in the bid document.

#### TERMS AND CONDITIONS FOR THE SUPPLY, ERECTION AND COMMISSIONING OF PUMPSETS

The prospective tenderer/ contractor are advised to inspect the respective the site and pump house where the installation are required before the execution of the work for verifying all the required details.

The pumpsets material offered should suit to the existing structures in the pump house.

The materials offered should be from the supply of materials from ready stock as far as possible and all the materials should conform to relevant IS standards.

The quoted rates for the materials should be inclusive of all taxes and F.O.R. at work site.

The quoted rate should be firm till the work is completed.

The rating and make of individual items offered should be as per relevant IS specification.

The materials offered should be delivered at pump house site. No freight charges will be paid for the transportation of materials.

The package should be marked "To the Assistant Executive Engineer, PH Sub Division, Kerala Water Authority, Kollam".

Any materials found defective should be replaced by the firm/ Contractor at their own cost.

The Contractor should furnish sufficient security deposit as specified in the work order and pledged in favour of the Assistant Executive Engineer, PH Sub Division, Kerala Water Authority, Kollam".

Documents presented through the Banks will not be accepted and the Kerala Water Authority will not be liable to pay any demurrage charges.

Entire works should be executed and completed within the time specified as per the directions of the departmental officers and in accordance with the rules and regulations of the Electrical Inspectorate. Any defects occurred during the one year guarantee period should be rectified by the Contractor at their own cost.

All approval required for the electrical installation works from the Electrical Inspectorate. KSEB should be obtained by the Contractor, after preparing the drawings and details.

The terms and conditions applicable to civil works as per from No GWD83 (Notice Inviting Tenders) are binding to this work also.

Pipes required for interconnection to the pumping main if required will be supplied by the department at free of cost at department rate. All other materials required such as pipes, specials, valves, jointing materials, cement, etc. and all labour charges should be borne by the Contractor.

The materials supplied for the work should be under the custody of the Contractor until the work is completed and the Contractor should arrange all the special tools, materials and labour required for the completion of the work.

Work contract tax, Income tax and other such recoveries as per the existing rules will be levied/ deducted from the Contract bill.

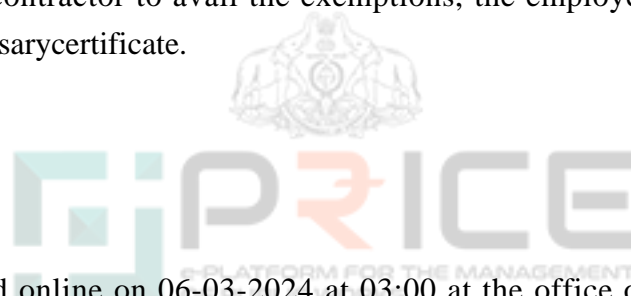
The Security deposit will be released only after the maintenance free guarantee period or 12 months from the date of satisfactory commissioning.

The tenderer / contractor must clearly understand that the settlement of claims either by part bills or by final bill will be made only according to the availability of budget provision and allotment of funds made with the Divisional Officer in charge of the work under the respective head of account in which the work is sanctioned and arranged and also subject to the seniority of such bills, no claim for the interest or for damages whatsoever shall be made for the belated settlement of claims of bills. No such claim shall be admitted by the Government.

The monetary benefit due to any reduction declared by Government of India/State in the statutory duties and levies after the tender submission should be passed on the Kerala Water Authority. For effecting this, the detailed break up of their purchase cost showing clearly the basic price, excise duty (in %), Sales tax, transportation, etc. shall invariably be noted. In cases where there are not mentioned any reduction shall be assessed by Kerala Water Authority with the present market rate of the material.

All duties, taxes and other levies payable by the Contractor under the contract or for any other cause as "On the date of invitation of Bid" shall be included in the rates and prices and the total bid price submitted by the bidder. The bidder shall be familiar with the tax laws of the

**E.D. EXEMPTIONS :** Excise and Customs duty exemptions are available generally to Government of India issued from time to time and shall quote his rate accordingly considering the exemptions available. The employer will give necessary certificates to the selected bidders to claim the exemption on specific request made by the Contractor. Any conditional bids in this regard shall not be accepted. The quoted rates shall be deemed to be based on the exemptions available and it will be responsibility of the Contractor to avail the exemptions, the employer's responsibility being limited to the issue of necessary certificate.

If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.
