Some of the empaneled firms raised certain difficulties faced while executing the Third Party Inspection. As the TPI charges is a percentage of basic price of materials to be inspected, they demanded issuing the basic price along with the calling letter issued to TPIA, fixation of charges for aborted and cancelled inspection and also for fixing a minimum time duration for releasing payment etc. The following directions are hereby issued considering the aforementioned issues

- 1. The Agreement authority while issuing call letter for inspection shall also provide a copy of the schedule of supply in work order to the TPI,
- 2. The charges for abortive inspections shall be paid by respective contractor and the same is applicable in case of cancelled inspections also, if the cancellation is due to the fault of contractor / manufacturer.
- 3. The payment of TPI shall be released within ten days from the date of receipt of the final tax invoice.
