ORDER

Kerala Water Authority is an autonomous authority for the development and regulation of water supply and wastewater collection and disposal in the State of Kerala. At present there are about 38 lakh consumers are provided with water supply. Jal Jeevan Mission (JJM) has been launched by Government of India and Government of Kerala which aims at providing Functional Household Tap Connections (FHTC) to every rural households by 2024 on a 50:50 cost sharing basis. This will increase the responsibility of KWA in drinking water sector of rural areas in the State. For strengthening the revenue collection activities of Kerala Water Authority and to ensure prompt consumer services to the public, it is necessary to re arrange the existing staff pattern in the offices of Kerala Water Authority.

The works of Jal Jeevan Mission in Idukki District are moving at a fast pace. However due to the vast geographical area of the district, it is understood that the Project Division, Kattappana handling the works find it difficult to execute and monitor the works with the present staff strength.

Vide read 1st above, it was directed to shift two posts of Assistant Executive Engineers of Sewerage Circle, Kochi and to be relocated and placed at the disposal of Project Division, Kattappana as Technical Assistant and as Assistant Executive Engineer, Munnar Project Sub Division, Idukki. Also

the abolished Section office of Elappara may be re-established by shifting a post of Assistant Engineer from Project Division, Kollam.

Under PH Sub Division, Peermade, the JJM works are done in 9 major gramapanchayaths around 1648 Square Kilo Meter space in Idukki district and as directed a new section office is needed in Kumily location. The matter has been discussed in detail and accordingly, the following rearrangement of posts are ordered with immediate effect for administrative convenience.

1. One post of Assistant Executive Engineer with incumbent Smt. Rincy Abraham (G45820) currently attached with PPD Regional Office Kochi 11 is hereby shifted and attached to Project Division, Kattappana as Technical Assistant.
2. One post of Assistant Executive Engineer with incumbent Smt. Sheeba C V (G14665) currently attached with Sewerage Circle, Kochi is hereby shifted and attached to Project Division, Kattappana as Assistant Executive Engineer, Munnar Project Sub Division, Idukki.

The formation of new PH Section office at Kumily under PH Sub Division, Peermade under PH Division, Thodupuzha under PH Circle, Muvattupuzha is hereby ordered with immediate effect for administrative convenience. The newly formed PH Section, Kumily covers four panchayaths namely Vandiperiyar, Kumily, Vandanmedu and Chakkupallam. The duty arrangement are as follows.

1. One post of Assistant Engineer with incumbent Sri. Bibin Jose (G43608) currently attached with Project Division, Kollam is hereby shifted and attached to PH Section, Kumily, under PH Sub Division, Peermade.
2. One vacant post of Overseer Gr III, currently attached with Water works Sub Division, Thrissur is hereby shifted and attached to PH Section, Kumily under PH Sub Division, Peermade.
3. One vacant post of Overseer Gr III, currently attached with WS Division, Kannur is hereby shifted and attached to PH Section, Kumily under PH Sub Division, Peermade.
4. One vacant post of Office Attendant currently attached with Head office, Jalabhavan, Thiruvananthapuram is hereby shifted and attached to PH Section, Kumily under PH Sub Division, Peermade.

The administrative control of newly formed PH Section, Kumily is attached to The Superintending Engineer, PH Circle, Muvattupuzha. The Chief Engineer (Central Region), Kochi shall make suitable rearrangement for the functioning of the above office including transfer of files and a detailed report shall be submitted to this office, with immediate effect.

The Controlling Officers are directed to relieve the incumbents in the shifted posts immediately. The sanctioned strength of the offices concerned shall be recasted accordingly by the respective heads of office. The respective Controlling Officers shall ensure compliance and make necessary arrangements for transfer of files and related works. The respective Controlling Officers are also directed to make necessary arrangements for the smooth function of the office. The Administrative Wing in the Head Office shall verify the same in due course.
