ORDER

Kerala Water Authority is a public sector undertaking which provides drinking water and waste water services in the State of Kerala. At present there are about 38 lakh consumers are provided with water supply. Jal Jeevan Mission (JJM) has been launched by Government of India and Government of Kerala which aims at providing Functional Household Tap Connections (FHTC) to every rural households by 2024 on a 50:50 cost sharing basis. This will increase the responsibility of KWA in drinking water sector of rural areas in the State. For strengthening the revenue collection activities of Kerala Water Authority and to ensure prompt consumer services to the public, it is necessary to re arrange the existing staff pattern in the offices of Kerala Water Authority.

At present, under PH Division Kasaragod there are 54042 FHTCs, under PH Division Vadakara 52590 FHTCs and under PH Division Sulthan Bathery 36423 FHTCs. The above 3 Division office has no sanctioned post of Revenue Officer. The matter has been discussed in detail and accordingly the following

convenience.

- 1. One post of Senior Superintendent / Revenue Officer currently attached with Payslip Section, Head Office, Jalabhavan, Thiruvananthapuram is hereby shifted and attached to PH Division, Kasaragod as Revenue Officer. Smt. Jayasree S, (G11243) Senior Superintendent now working in present Shifted Post is hereby transferred and posted to PH Division, Kottarakkara in the existing vacancy.
- 2. One vacant post of Senior Superintendent / Revenue Officer currently attached with Administrative Wing, Head Office, Jalabhavan, Thiruvananthapuram is hereby shifted and attached to PH Division, Vadakara as Revenue Officer.
- 3. One post of Head Clerk with incumbent Sri Madhusoothanan K M, (G12387), from Public Health Section No I Kothamangalam, under Public Health Sub Division, Kothamangalam under PH Division, Muvattupuzha is shifted and attached to PH Division, Sulthan Bathery for revenue related activities.

The Controlling Officers are directed to relieve the incumbents in the shifted posts immediately. The sanctioned strength of the offices concerned shall be recasted accordingly by the respective heads of office. The respective Controlling Officers shall ensure compliance and make necessary arrangements for transfer of files and related works. The respective Controlling Officers are also directed to make necessary arrangements for the smooth function of the office. The Administrative Wing in the Head Office shall verify the same in due course.
