ORDER

Kerala Water Authority is an autonomous authority for the development and regulation of water supply and wastewater collection and disposal in the State of Kerala. At present there are about 38 lakh consumers are provided with water supply. Jal Jeevan Mission (JJM) has been launched by Government of India and Government of Kerala which aims at providing Functional Household Tap Connections (FHTC) to every rural households by 2024 on a 50:50 cost sharing basis. This will increase the responsibility of KWA in drinking water sector of rural areas in the State. For strengthening the project activities of Kerala Water Authority and to ensure prompt consumer services to the public, it is necessary to re arrange the existing staff pattern in the offices of Kerala Water Authority. Accordingly, the following rearrangement of posts of Overseer Gr III / Tracer from office posts are ordered with immediate effect for administrative convenience.

1. One vacant post of Overseer Gr III from PH Sub Division Alappuzha is shifted and attached to PH Section Nedumpuram under PH Sub Division, Thiruvalla under PH Division, Thiruvalla.
2. One vacant post of Overseer Gr III from PPD Regional Office, Thiruvananthapuram is shifted and attached to Water Supply Section Parasala under WS Sub Division, Neyyattinkara under WS Division, Neyyattinkara.
3. One post of Overseer Gr III from Chief Engineer (Southern Region), Thiruvananthapuram with incumbent Smt.Vijitha.V.L (G10443) are shifted and attached to Water Works Central Sub Division Thiruvananthapuram under PH Division (North), Thiruvananthapuram.

The Controlling Officers are directed to relieve the incumbents in the shifted posts immediately. The sanctioned strength of the offices concerned shall be recasted accordingly by the respective heads of office. The respective Controlling Officers shall ensure compliance and make necessary arrangements for transfer of files and related works. The Administrative Wing in the Head Office shall verify the same in due course.
