Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport)

Section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012) empowers every department, of the Government, Heads of Department, Local Self Government Institutions and Statutory Bodies to notify in the Gazette, the services that will be rendered by each of them along with details of stipulated time limit, Designated Officers, First Appellate Authority and Second Appellate Authority. In accordance with the provisions of the said section, notification no. KWA/JP/E1/9387/2012 was issued on 06.06.2024 and published in the Kerala Gazette Extraordinary No.1804 dated 07.06.2024. Now it has been decided to amend the said notification in order to incorporate certain other services also under the purview of the Kerala State Right to Service Act, 2012 (18 of 2018), which had been in force in Kerala Water Authority vide order No. KWA/HO/RMC/R1/1088/2013 with effect from 16.07.2013.

The notification is intended to achieve the said purpose.
