The promotee will be on probation as per paper read 11 above. Before admitting the promotee for duty, the Controlling Officers shall obtain an undertaking as appended herewith from the incumbent and the same shall be pasted in the Service Book.

The date of relieving and joining duty of the incumbents shall be reported to this office along with an attested copy of the undertaking to this office without fail. Before leaving the present offices, the promotee should hand over their charges along with the files and the documents including 'Memorandum of Works' to the officers suggested by the controlling officer. The details of documents handed over and a hard copy of 'Memorandum of Works' (soft copy to be emailed), are to be submitted to the controlling officers and the controlling officers should ensure that none of the incumbents are relieved without proper handing over of charges and submission of 'Memorandum of Works' to strengthen institutional memory and professional business continuity.
