The lack of availability of skilled resources in the area of Information Technology and Project Management is creating dependency on external agencies in the implementation of e-Governance projects in Kerala Water Authority.

The Authority vide resolution No. 10351 has resolved to form a Virtual IT cadre in KWA and develop in a phased manner based on which interested staff were requested to communicate their willingness before 30.06.2016 to join the Virtual IT Team. 20 applications were received within the last date (as per the list of incumbents attached) and the details were placed before the HLC on 18.07.2016.

The HLC approved the induction of the 20 employees into the Virtual IT Cadre with the following terms and conditions:

- 1. All the 20 staff who has applied within the stipulated time shall be inducted into the Virtual IT Cadre in KWA; they shall be provided with adequate training for enabling them to handle IT related jobs.
- 2. There shall be no extra remuneration provided to the staff for the work done under the Virtual IT Cadre.
- 3. The staff shall be provided with necessary infrastructure like laptop, net connection, CUG etc if the nature of job allotted to them demands for the same. The Secretary KWA is entrusted for procurement of the infrastructure after due assessment.
- 4. The performance of the employee will be observed for a period of one year and based on the performance they will be regularized in the virtual IT cadre.



- 5. An entry regarding the officer's induction into Virtual IT Cadre shall be made in service book if the performance of the employee within Virtual IT Cadre is found satisfactory.
- 6. As far as possible, an employee included in virtual IT cadre shall not be transferred. If a transfer becomes inevitable this shall be made with the consent of IT Wing only.

Under the above circumstances, sanction is hereby accorded for the formation of Virtual IT Cadre in KWA based on the above mentioned terms and conditions.
