Res. No. 6794 The Authority resolved to delegate powers to the Managing Director/Accounts Member at the Head Office level and to the regional Chief Engineers at region level to waive the fine charged to non-domestic consumers, tentatively on a trial basis up to 31/3/2005 and thereafter the same is to be reviewed personally by Accounts Member/Managing Director, subject to the following conditions:

- (i) The consumer shall be ready for a one-time settlement of all old dues and shall submit an undertaking agreeing to pay water charges promptly in future.
- (ii) The consumer shall pay 14.5% compound interest per annum instead of fine amounting to 2% of the outstanding charges for every month. If the officers are found responsible for the outstanding charges, due to the reason of delay in serving the bills in time, a compound interest of 14.5% per annum will be charged against the concerned officers who has made this delay.
- (iii) The incentive in relaxation of fine shall be allowed at the time of actual payment of dues.
- (iv) The Chief Engineer shall furnish a monthly report on every 1st day of the month of the details of incentive he had allowed during the previous month and the resultant additional collection of revenue to the Managing Director/Accounts Member.
- (v) The Managing Director shall report the total incentive that has been allowed in a month and resultant additional revenue recovery to the Authority while reporting on the billing and collection of revenue.
- (vi) The Managing Director may introduce the procedure immediately. However, a request for amendment to the Regulations may be sent to Government intimating that the procedure has been introduced in anticipation of the approval of the Government.

(vii) To avoid any possible misuse of the procedure, the Internal Audit Wing of Kerala Water Authority shall review each such waiver of fine ordered by the Managing Director/Accounts Member/Regional Chief Engineer during their inspection of Main Office/Divisions and report deviations/objections if any in the inspection report.
