Tender was invited vide ref (1) and ref (2), for the empanelment of Third party Inspection Agencies (TPIAs) for various pipes, specials, valves etc in KWA and the proceedings of empaneled TPIAs were issued vide ref (3). M/s CIPET had requested for renewing the agreement with KWA for continuing the existing contract for the Pre-delivery inspection and Post-delivery testing of uPVC, HDPE,GRP Pipes and Fittings, MS, GI and DI Pipes. Being an organization under Government of India, the Committee recommended empaneling M/s CIPET on their request, since they are

eligible as per the pre-qualification criteria, even though they had not participated in the tender. But M/s CIPET has not accepted the L1 rate of the tender and had not executed the agreement. Vide ref (4) M/s CIPET has requested to allow them to continue as TPIA at the rate fixed by them (Higher than the L1 rate of tender) as their rates are approved by Governing council, Ministry of Chemicals & Fertilizers Govt of India which is uniform through out the country.

Being a Government of India firm and considering the requests referred in (4), it has been decided to empanel M/s CIPET with the rate submitted by them vide reference (6), and an agreement has been executed with the firm subjected to terms and conditions. As per the letter referred in (5), it was already informed you that, out of the eight firms empaneled vide read (3), only six firms had executed the agreement with KWA. Now, M/s CIPET has also executed the agreement with KWA on 11/04/2024. The agreement along with rates are forwarded here with for your information.

As the respective KWA officers are selecting and assigning the TPIA on rotation basis, consent from the contractor concerned may be ensured before assigning TPIA for the work.

The updated list of Third Party Inspection Agencies (TPIA) for various items to be procured by KWA is appended with this. Note that, the validity of this empanelment is 2 years from the date of execution of agreement or till the next agreement is concluded for TPI, whichever is later.
